<u>Time and Place for Filing Sealed Proposals</u>. Sealed bids for the work comprising the repair and improvement as stated below must be filed before 1:00 P.M. on March 26, 2024, in the office of the City Clerk, City Hall, 2 North 7th Street, Estherville, Iowa 51334.

<u>Time and Place Sealed Proposals Will be Opened and Considered.</u> Sealed proposals will be opened and bids tabulated at 1:00 P.M. on March 26, 2024, by the City Clerk, City Hall, 2 North 7th Street, Estherville, Iowa 51334 for consideration by the City of Estherville at its meeting at 5:00 P.M. on April 1 2024, City Hall, 2 North 7th Street, Estherville, Iowa 51334. The City of Estherville reserves the right to reject any and all bids, to waive informalities or technicalities in any bid, and to enter into such contract, or contracts, as it shall deem to be to the best interest of the City of Estherville.

<u>Time for Commencement and Completion of Work.</u> Work on the improvements shall commence upon approval of the contract by the City Council and as stated in the Notice to Proceed. All work under the Contract must be start on or after July 29, 2024. All work must be substantially complete in 34 Calendar Days. The working days provided for the project cover all work related to Phase 1 and Phase 2.

Work under phase 2, which includes work in the intersection of the two runways requiring closure of the airport, must be completed during the calendar month of August 2024. Phase 2 work shall be completed concurrently with Phase 1 work. All work requiring closure of the airport (Phase 2) shall be completed in a single closure of no more than 7 calendar days. The airport would prefer it if the closure, associated with phase 2 improvements occurred starting August 12, 2024. However, flexibility could be granted for the closure to meet weather or the contractors schedule, so long as the period of closure for phase 2 occurred entirely in the calendar month of August 2024. The contractor shall provide the airport with a minimum of 6 calendar days' notice of impending phase 2 work to allow for issuance of a NOTAM by the airport manager to let the airport manager inform the tenants of the construction schedule.

If remarking of the pavement markings within the runway intersection area, defined by the limits of phase 2 work improvements area, cannot be completed during the single closure noted above for Phase 2, it shall be permissible to allow the contractor to close the airport for a single closure that occurs starting at 5:00 p.m. and the airport would remain closed to 6:30 am the following morning. Barricades and closure "X's" would not be allowed to be placed for the closure prior to 5:00 p.m. and must be picked up by no later than 6:30 a.m. This closure for runway markings in the intersection area will only be allowed once for the project and requires the contractor to provide a minimum of 6 calendar days' notice to allow for issuance of a NOTAM by the airport manager and to let the airport manager inform the tenants of the construction schedule.

Liquidated damages as set forth in Section 00500 – Contract.

Bid Security. Each bidder shall accompany its bid with bid security, as defined in lowa Code Section 26.8, as security that the successful bidder will enter into a contract for the work bid upon. The bidder's security shall be in an amount equal to 5% percent of the total amount of the bid. The bid shall contain no condition except as provided in the specifications.

If the bidder fails to execute the contract and to furnish an acceptable performance and payment bond or provide a Certificate of Insurance within ten (10) days after acceptance of the bid by the City of Estherville, the bid security may be forfeited or cashed by the City of Estherville as liquidated damages.

<u>Preference of Products and Labor.</u> By virtue of statutory authority, further preference will be given to products and provisions grown and coal produced within the State of Iowa, and to Iowa domestic labor, to the extent lawfully required under Iowa statutes. Failure to submit a fully completed Bidder Status Form with the bid may result in the bid being deemed nonresponsive and rejected.

<u>Sales Tax Exemption Certificates.</u> The bidder shall not include sales tax in the bid. The City of Estherville will distribute tax exemption certificates and authorization letters to the Contractor and all subcontractors who are identified. The Contractor and subcontractor may make copies of the tax exemption certificates and provide a copy to each supplier providing construction materials. These tax exemption certificates and authorization letters are applicable only for this specific project under the Contract.

<u>Award of Contract.</u> All proposals submitted in accordance with the instructions presented herein will be subject to evaluation. Bids may be held by the City of Estherville until July 15, 2024 for the purpose of conducting the bid evaluation.

The Owner will base the award of contract upon the lowest aggregate sum proposal submitted from those bidders the Owner confirms as being responsive and responsible. The right is reserved, as the City of Estherville may require, to reject any and all bids and to waive any informality in the bids received.

Prospective Bidders are hereby advised that award of contract is contingent upon the owner receiving Federal funding assistance under the Airport Improvement Program.

Federal Provisions

This project is subject to the following Federal provisions, statutes, and regulations:

Equal Employment Opportunity - Executive Order 11246 and 41 CFR Part 60: The Bidder's attention is called to the "Equal Opportunity Clause" and the "Standard Federal Equal Employment Opportunity Construction Contract Specifications" set forth within the supplementary provisions. The successful Bidder shall not discriminate against any employee or applicant for employment because of race, color, religion, sex, or national origin. The Contractor will take affirmative action to ensure that applicants are employed, and that employees are treated during employment without regard to their race, color, religion, sex, or national origin.

Goals for Minority and Female Participation – Executive Order 11246 and 41 CFR Part 60:

If the contractor performs construction work in a geographical area located outside of the geographical area where the work is actually performed. With regard to this second area, the contractor also is subject to the goals for both its Federally involved and non-federally involved construction.

<u>Certification of Non-Segregated Facilities – 41 CFR Part 60</u>: A certification of Non-segregated Facilities must be submitted prior to the award of a federally-assisted construction contract exceeding \$10,000 which is not exempt from the provisions of the Equal Opportunity Clause.

Section 50101, all steel and manufactured products installed under an AIP assisted project must be produce in the United States unless the Federal Aviation Administration has granted a formal waiver.
