<u>Time and Place Sealed Proposals Will be Opened and Considered</u>. Sealed proposals will be opened and bids tabulated at 1:00 P.M. on April 16, 2024, at City Hall by the City Manager, City Hall, 122 1st Avenue NW, Hampton, Iowa 50441 for consideration by the City of Hampton at its meeting at 6:00 PM on April 25, 2024, City Hall, 122 1st Avenue NW, Hampton, Iowa 50441. The City of Hampton reserves the right to reject any and all bids, to waive informalities or technicalities in any bid, and to enter into such contract, or contracts, as it shall deem to be to the best interest of the City of Hampton.

<u>Time for Commencement and Completion of Work.</u> Work on the improvement shall commence upon approval of the contract by the City Council and as stated in the Notice to Proceed. All work under the Contract must be substantially complete in twenty days (20) days for the base bid and additional six (6) working days Working Days. Liquidated damages as set forth in Section 00500 – Contract.

<u>Bid Security.</u> Each bidder shall accompany its bid with bid security, as defined in lowa Code Section 26.8, as security that the successful bidder will enter into a contract for the work bid upon. The bidder's security shall be in an amount equal to 5% percent of the total amount of the bid. The bid shall contain no condition except as provided in the specifications.

The Contractor and subcontractor may make copies of the tax exemption certificates and provide a copy to each supplier providing construction materials. These tax exemption certificates and authorization letters are applicable only for this specific project under the Contract.

The Owner will base the award of contract upon the lowest aggregate sum proposal submitted from those bidders the Owner confirms as being responsive and responsible. The right is reserved, as the City of Hampton may require, to reject any and all bids and to waive any informality in the bids received.

Prospective Bidders are hereby advised that award of contract is contingent upon the owner receiving Federal funding assistance under the Airport Improvement Program.

Federal Provisions

This project is subject to the following Federal provisions, statutes, and regulations:

Equal Employment Opportunity - Executive Order 11246 and 41 CFR Part 60: The Bidder's attention is called to the "Equal Opportunity Clause" and the "Standard Federal Equal Employment Opportunity Construction Contract Specifications" set forth within the supplementary provisions. The successful Bidder shall not discriminate against any employee or applicant for employment because of race, color, religion, sex, or national origin.
