Each bid must be accompanied in a separate envelope by a bid bond, a cashier's check or certified check drawn on a state-chartered or federally chartered bank, or a certified share draft drawn on a state-chartered or federally chartered credit union in an amount of ten per cent (10%) of the total value of the Proposal, and made payable to the Owner as a security that the bidder will enter into a contract for the Work within fifteen (15) days after the award of the contract to such bidder.

The successful bidder will be required to furnish performance and payment bonds, each in an amount equal to one hundred percent (100%) of the contract price, as security for the faithful performance and payment of all of Contractor's obligations under the Contract Documents.
