<u>Time and Place for Filing Sealed Proposals</u>. Sealed bids for the work comprising the repair and improvement as stated below must be filed before 11:00 A.M. on July 30, 2024, in the office of the City Clerk, City Hall, 515 Clark Avenue, Ames, Iowa 50010.

<u>Time and Place Sealed Proposals Will be Opened and Considered</u>. Sealed proposals will be opened and bids tabulated at 11:00 A.M. on July 30, 2024, by the City of Ames Purching Staff, at City Hall, in Conference Room 235, 515 Clark Avenue, Ames, Iowa 50010 for consideration by the City of Ames at its meeting at 10:00 A.M. on August 6, 2024, City Hall, 515 Clark Avenue, Ames, Iowa 50010. The City of Ames reserves the right to reject any and all bids, to waive informalities or technicalities in any bid, and to enter into such contract, or contracts, as it shall deem to be to the best interest of the City of Ames.

<u>Time for Commencement and Completion of Work.</u> Work on the improvement shall commence upon approval of the contract by the City Council and as stated in the Notice to Proceed. All work under Phase 1 must be substantially completed on or before Friday August 15, 2025.

Phase 2 shall be utilized for the removal of pavement, grading, electrical improvements and seeding within the Taxilane Object Free Area. While working on Phase 2, the contractor shall substantially complete all improvements within this area within 27 calendar days. Phase 2 shall be completed concurrently with Phase 1. Once work is started on Phase 2, it shall actively be completed until completion.

Starting October 1, 2024, the contractor may begin cutting trees for the project. All trees must be cut down prior to March 31, 2025. After March 31, 2025, the contractor shall not be allowed to cut down any trees on the project. Any trees cut down prior to March 31, 2025 will be allowed to be removed, grubbed, and/or processed after April 1, 2025.

Access to some of the fencing adjacent to agricultural areas will not be accessible until all crops are removed from the area. Harvesting of the crops is likely to not occur until on or about mid-November 2024. In areas where farm fields exist, the contractor will be allotted up to 20' of crop disturbance from the proposed fence line to construct to proposed fencing improvements. Additional disturbance outside of the 20' allotted for constructability will be subject to liquidated damages.

Liquidated damages as set forth in Section 00500 – Contract.

**<u>Bid Security.</u>** Each bidder shall accompany its bid with bid security, as defined in Iowa Code Section 26.8, as security that the successful bidder will enter into a contract for the work bid upon. The bidder's security shall be in an amount equal to 5% percent of the total amount of the bid. The bid shall contain no condition except as provided in the specifications.

If the bidder fails to execute the contract and to furnish an acceptable performance and payment bond or provide a Certificate of Insurance within ten (10) days after acceptance of the bid by the City of Ames, the bid security may be forfeited or cashed by the City of Ames as liquidated damages.

<u>Preference of Products and Labor</u>. By virtue of statutory authority, further preference will be given to products and provisions grown and coal produced within the State of Iowa, and to Iowa domestic labor, to the extent lawfully required under Iowa statutes. Failure to submit a fully completed Bidder Status Form with the bid may result in the bid being deemed nonresponsive and rejected.

<u>Sales Tax Exemption Certificates.</u> The bidder shall not include sales tax in the bid. The City of Ames will distribute tax exemption certificates and authorization letters to the Contractor and all subcontractors who are identified. The Contractor and subcontractor may make copies of the tax exemption certificates and provide a copy to each supplier providing construction materials. These tax exemption certificates and authorization letters are applicable only for this specific project under the Contract.

<u>Award of Contract.</u> All proposals submitted in accordance with the instructions presented herein will be subject to evaluation. Bids may be held by the City of Ames for a period not to exceed **Ninety (90) days** from the date of the bid opening for the purpose of conducting the bid evaluation.

The Owner will base the award of contract upon the lowest aggregate sum proposal submitted from those bidders the Owner confirms as being responsive and responsible. The right is reserved, as the City of Ames may require, to reject any and all bids and to waive any informality in the bids received.

Prospective Bidders are hereby advised that award of contract is contingent upon the owner receiving Federal funding assistance under the Airport Improvement Program.

## Federal Provisions (Applies Division 1 Work)

This project is subject to the following Federal provisions, statutes, and regulations:

Equal Employment Opportunity - Executive Order 11246 and 41 CFR Part 60: The Bidder's attention is called to the "Equal Opportunity Clause" and the "Standard Federal Equal Employment Opportunity Construction Contract Specifications" set forth within the supplementary provisions. The successful Bidder shall not discriminate against any employee or applicant for employment because of race, color, religion, sex, or national origin. The Contractor will take affirmative action to ensure that applicants are employed, and that employees are treated during employment without regard to their race, color, religion, sex, or national origin.

If the contractor performs construction work in a geographical area located outside of the geographical area where the work is actually performed. With regard to this second area, the contractor also is subject to the goals for both its Federally involved and non-federally involved construction.
