Managing teams responsible for local watershed coordination efforts and upstream conservation practices.

#### Job Duties and Responsibilities

- Participates as a Team member for economic development and growth-related activities for utility services and programs
- Coordinates the investigation into and respond to complaints
- Coordinates with water and wastewater regulatory and legislative priorities with the city's legislative coordinator on risks and quality
- Serves as Utilities liaison to City's grant development team and oversees successful grant funding requirements
- Approves monthly contributor reports and invoicing and determines charges for special sewer rental accounts;
   oversees pretreatment compliance and enforcement activities and maintains confidential records
- Participates in the development of revenue budgets; develops and maintains utility cost-of-service model;
   participates in the financial planning and projection of revenues for the water pollution control
- Supervises the work of assigned personnel, including assigning and reviewing work, providing guidance, and conducting performance evaluations
- Evaluates the treatability of industrial wastes, recommends approval or denial of requests for waste acceptance
- · Attends conferences, City and public meetings, and presents to agriculture groups
- Provides oversight and direction over environmental initiatives such as watershed nutrient reduction coordination, energy management and sustainability efforts
- General oversight and responsibility for the operation and results of a State certified lab
- Engages and stays up-to-date on emerging contaminants of concern in wastewater and drinking water and provides insight to City leadership to increase understanding and minimize risk
- Oversees processes and systems related to Process Safety Management and Risk Management Planning for the Utilities department
- Monitors emerging contaminant regulations and advises on potential impacts
- Performs related work as required
