<b>DESCRIPTION OF WORK:</b>	The project shall consist of providing all materials, equipment and labor necessary to install the work as defined as follows: Base Bid: Construction of 9'x7'x13' vault chamber with timber framed building including, metal siding and roofing, electrical, process piping, and HVAC systems. Provide and install UV Disinfection system as specified. Work includes all necessary grading, erosion control, mobilization water and natural gas service piping and other associated appurtenances and miscellaneous work items. All Work and equipment are to be in accordance with the Plans, Specifications and Contract Documents on file with the Homestead Sanitary District, Homestead, Iowa, which are by this reference made a part of this Notice as though fully set out and incorporated herein.
<b>SALES TAX EXEMPTION</b>	<b>The Bidder is <u>NOT</u> eligible to receive an exemption from the State of Iowa Sales Tax. State of Iowa Sales Tax shall be included in the bid.</b>
<b>PREFERENCE</b>	By virtue of statutory authority, a preference will be given to products and provisions grown and coal produced within the state of Iowa.
<b>BID GUARANTY:</b>	Bid security in the form of a cashier's check or certified check drawn on a state-chartered or federally chartered bank, or a certified share draft drawn on a state-chartered or federally chartered credit union, or a bidder's bond with corporate surety satisfactory to the Board of Trustees, in the amount of 10% of the bid.
<b>COMPLETION DATE:</b>	Work shall commence within ten (10) calendar days after receipt of the written "Notice to Proceed". All work shall be completed by <b>September 1, 2026</b> subject to any time extension that may be granted by the Board of Trustees.
<b>PERFORMANCE/ PAYMENT /MAINTENANCE BOND:</b>	One hundred percent (100%) of the bid, with a maintenance period of <b>three (3)</b> years from the time of final project acceptance by the Owner.
<b>PAYMENTS:</b>	Monthly estimates equivalent to ninety-five percent (95%) of the Contract value of the work completed during the preceding calendar month with 5% retainage. Remaining retainage, if any, will be paid within 30 days after final acceptance by the Board of Trustees.
