Substantial completion shall include reestablishing full-width paved access for vehicles both entering and existing the site. Final completion of all other remaining work items not impacting access to the site shall follow by Friday, October 17, 2025. Access to public services will be disrupted during this closure. Therefore, it is imperative to restore two-way vehicular access to the site by the specified date. Liquidated damages for noncompliance with said completion provisions will be assessed at the rate of One Thousand Dollars (\$1,000.00) for each calendar day thereafter that the work remains incomplete.

Public Hearing on Proposed Contract Documents and Estimated Costs for Improvement. A public hearing will be held by the Clive City Council on the proposed contract documents (plans, specifications and form of contract) and estimated cost for the improvements, as bid by the selected bidder, at its meeting at 6:00 pm on September 11, 2025, in said Council Chambers of the City Hall, 1900 NW 114th Street, Clive, Iowa.

<u>Preference of Products and Labor</u>. Preference shall be given to domestic construction materials by the contractor, subcontractors, material, men and suppliers in performance of the contract and, further, by virtue of statutory authority, preference will be given to products and provisions grown and coal produced within the State of Iowa, and to Iowa domestic labor, to the extent lawfully required under Iowa statutes.

<u>Resident Bidder Preference Law.</u> Iowa Code 73A.21 outlines the reciprocal resident bidder and labor force preference statute. The Iowa Department of Labor (DOL) has adopted administrative rules to enforce this law. Failure to submit a fully completed Bidder Status Form with the bid may result in the bid being deemed nonresponsive and rejected.

<u>Sales Tax.</u> The bidder shall not include sales tax in the bid. The City of Clive will distribute tax exemption certificates and authorization letters to the Contractor and all Subcontractors who are identified. The Contractor and Subcontractors may make copies of the tax exemption certificates and provide a copy to each supplier providing construction materials. These tax exemption certificates and authorization letters are applicable only for this specific project under the Contract.

General Nature of Public Improvement. This project includes all materials, equipment, transportation and labor necessary for the replacement of the existing approach at Clive City Hall and the Public Library. Project items include drive and parking lot pavement, sidewalk, traffic control, restoration, and associated work. Specific project location along with the kind and approximate quantity of materials to be used shall be as set forth in the Plans and Specifications.
