# Time for Commencement and Completion of Work

The work under the proposed Contract shall commence upon issuance of the written Notice to Proceed. The proposed water improvements listed shall be fully completed on or before October 15, 2026. The Bidder agrees to pay as liquidated damages the sum of \$500 for each consecutive calendar day after the specified completion date that the project is not fully completed.

### **Bid Security**

Each bidder shall accompany its bid with bid security as defined in Section 26.8 of the Code of Iowa. Bid security shall be 10% of the bid amount.
