Time and Place Sealed Quotes Will be Opened and Considered. Sealed quotes will be opened and quotes tabulated at 10:00 AM on December 8, 2025 in the office of City Clerk, City of Swisher, Iowa City Hall, 66 2nd Street SW, Swisher, IA 52338 for consideration by the City Council of City of Swisher, Iowa at its meeting on December 8, 2025 at 6:30 PM. The City of Swisher, Iowa reserves the right to reject any and all quotes.

Time for Commencement and Completion of Work. Work on the improvement shall commence within 10 days of the date specified on the Notice to Proceed. Notice to Proceed shall be no later than January 5, 2026, work shall be substantially complete on or before February 27, 2026, and shall be fully completed on or before March 20, 2026. Damages in the amount of Two Hundred-Fifty (\$250) per day will be assessed for each day the work remains incomplete.

Bid Security. A bid security is not required for this quote.

Preference of Products and Labor. Preference shall be given to domestic construction materials by the contractor, subcontractors, material, men, and suppliers in performance of the contract and, further, by virtue of statutory authority, preference will be given to products and provisions grown and coal produced within the State of Iowa, and to Iowa domestic labor, to the extent lawfully required under Iowa statutes.

Sales Tax Exemption Certificates. The contractor shall not include sales tax in the quote. The City of Swisher, Iowa will distribute tax exemption certificates and authorization letters to the Contractor and all subcontractors who are identified. The Contractor and subcontractor may make copies of the tax exemption certificates and provide a copy to each supplier providing construction materials. These tax exemption certificates and authorization letters are applicable only for this specific project under the Contract.

General Nature of Public Improvement. Approximately 1,015 feet of CIPP Main Lining of existing 8" sanitary sewer and sanitary sewer spot repair at approximately 108 feet upstream of Manhole 20, including sewer cleaning, root removal, and CIPP service pipe connections as necessary. Lining and repairs will occur in Region 5 as identified in the Swisher Sewer Maintenance Plan.
