#### Time and Place Sealed Bids Will Be Considered

Bids will be considered by the Board of Trustees during their meeting beginning at 4:00 P.M. on December 16, 2025, in the office of the General Manager at Ottumwa Water & Hydro, 230 Turner Drive, Ottumwa, Iowa.

#### Time for Commencement and Completion of Work

The work under the proposed Contract shall commence upon issuance of the written Notice to Proceed. The proposed water main improvements listed shall be fully completed on or before September 30, 2026. The Bidder agrees to pay as liquidated damages the sum of \$500 for each consecutive calendar day after the specified completion date that the project is not fully completed.

### **Bid Security**

Each bidder shall accompany its bid with bid security as defined in Section 26.8 of the Code of Iowa. Bid security shall be 10% of the bid amount.
