The Project includes the following Work:

Construction of a SAGR System including all necessary piping and valves to connect to the existing sewer pipes, installation of a blower, aeration piping, and appurtenances, flow meter relocation, composite sampler, lagoon rip-rap, perimeter fencing, granular surfacing, seeding, overall wastewater management
