Sealed Bids for the construction of the Forevergreen Road and Jasper Avenue Improvements project will be received, by City of North Liberty, at North Liberty City Administration Building, 360 N. Main Street, North Liberty, IA 52317 US, until 10:00 AM local time on January 15, 2026, at which time the Bids received will be publicly opened and read.

The Project will involve the following: Construction of Forevergreen Road and Jasper Avenue roadway. Work includes PCC roadway paving, PCC trail, grading, subgrade treatment, storm sewer, water main, pavement marking and signing, PCC pavers, traffic control, plantings, lighting, and site restoration.

The work must commence by the late start date of April 6, 2026 and must be substantially completed by November 14, 2026.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis, as indicated in the Bid Form.
