

NOTICE TO BIDDERS

Notice is hereby given that sealed bids will be received by the City Administrator of the City of Sergeant Bluff, Sergeant Bluff, Iowa, at City Hall, 501 4th Street, Sergeant Bluff, Iowa 51054 until **2:00 PM**, on **February 12, 2026**, at said time and place, proposals will be publicly opened and read. The City Council will meet at Council Chambers, 501 4th Street, Sergeant Bluff, Iowa 51054 on February 24, 2026 at 5:30 PM, at which time and place the said City Council will consider adoption of the plans and specifications, and proposed form of contract for the Electric Distribution Improvements - 2026 project, which are now on file at the office of the Utilities. At said meeting, the City Council will conduct a public hearing and take action on the received proposals.

The proposed construction is described in general as follows:

Work specified herein consists of underground primary and secondary cable installation on existing right-of-way or easements, including the installation of padmount transformer box pads, sectionalizing cabinets, secondary pedestals, and other equipment, all as shown on the staking sheets. The Contractor shall take all necessary precautions in avoiding existing utilities.

The above work shall be in accordance with the specifications and proposed form of contract now on file in the offices of, the City of Sergeant Bluff, Sergeant Bluff, Iowa, by this reference made a part hereof, as though fully set out and incorporated herein.

Each bid shall be made out on a blank form furnished by the City of Sergeant Bluff and must contain bid security as required by Iowa Code Section 26.8. The bidder's security shall be in the form of either (1) a cashier's check or certified check drawn on a state chartered or federally chartered bank, in an amount equal to ten (10) percent of the amount of the Bid; or (2) a certified share draft drawn on a state-chartered or federally chartered credit union, in an amount equal to ten (10) percent of the amount of the Bid; or (3) a Bid Bond executed by a corporation authorized to contract as a surety in the State of Iowa, in an amount equal to ten (10) percent of the amount of the Bid. The bid security shall be made payable to the City of Sergeant Bluff. The bid security must not contain any conditions either in the body of or as an endorsement thereon. Such bid security shall be forfeited to the City of Sergeant Bluff as liquidated damages in the event the successful bidder fails or refuses to enter into a contract within fifteen (15) days after the award of the contract and post satisfactory Performance and Payment Bonds.

The sealed envelope containing the bid shall be clearly marked "BID ENCLOSED – ELECTRIC DISTRIBUTION IMPROVEMENTS - 2026" on the outside of the envelope.

Payment to the Contractor for said construction work will be made from cash on hand of such other funds that legally may be used or obtained for such purposes. Estimates will be paid monthly by the Utility to the Contractor in accordance with the following schedule:

Ninety-seven (97) percent upon certification of units completed; three (3) percent within thirty (30) days after final completion and acceptance.

Construction may be started after the execution of the Construction Agreement (the Contract) and the issuance of the Notice to Proceed. Substantial Completion of the project shall be no later than September 30, 2026. See the "Construction Schedule" of the Technical Specifications for special instructions relating to this project.

By virtue of statutory authority, a preference will be given to products and provisions grown, and coal produced within the State of Iowa, and preference shall be given to Iowa domestic labor in the construction of said improvements. The Owner will, in evaluating Bids, consider the requirements of the resident bidder preference law, and allow such preferences to resident bidders as are required to be allowed under State Law. Bidder shall, when submitting a Bid, furnish an executed Bidder Status Form for the Owner to use when applying the preference law. Failure to submit a fully completed Bidder Status Form with the bid may result in the bid being deemed nonresponsive and rejected.

City of Sergeant Bluff reserves the right to defer acceptance of any bid for a period not to exceed thirty (30) days after the date bids are received and no bid may be withdrawn during this period. The Utilities also reserves the right to waive irregularities, reject any or all bids, and enter into such contract as it shall be deemed to be in the best interest of the Utility.
