

**NOTICE OF PUBLIC HEARING AND LETTING

Online bids for the construction of certain Fort Dodge Regional Airport improvements and work incidental thereto on an improvement project described in general as “**Fort Dodge Regional Airport: Acquire Snow Removal Equipment**”, **must be filed before 3:00 p.m. on the 4th day of March 2026**, utilizing online bidding through QuestCDN (Ebid Reference No. 10011944), in accordance with the Specifications now on file in the office of the **Airport Manager**. At said time and place, Proposals will be opened and tabulated by the Engineer.

No pre-bid conference is scheduled for this project.

Proposals received will be presented to the Airport Commission and considered at a meeting presided over by the Chair, to be held **in the Terminal Building at the Fort Dodge Regional Airport, Fort Dodge, Iowa at 5:30 p.m. on the 9th of March 2026**. At such time and place, the Commission shall also hold a Public Hearing on the proposed Specifications, form of Contract and estimate of cost for the construction of said improvements hereinafter described in accordance with the provisions of Chapter 384, Code of Iowa, **at 5:30 p.m. on the 9th of March 2026 at the Fort Dodge Regional Airport Terminal Building, Fort Dodge, Iowa**. At the hearing, the Commission will receive and consider any comments made by any interested party, to the Plans and Specifications, proposed form of Contract, and the estimate of the cost for the project.

This project will involve the following snow removal equipment acquisitions:

All bids must be on file on QuestCDN.com on or before the time herein set. Each bid shall be accompanied by a Bid Bond in an amount equal to **ten (10%)** of the total amount of the bid. Bid Bonds must be on the form provided with the Contract Documents.

The Bid Bond may be forfeited and the proceeds retained as liquidated damages if the bidder fails to execute a contract or file acceptable performance bonds or provide an acceptable certificate of insurance within fifteen (15) calendar days after the acceptance of his proposal by resolution of the City Council. **No bidder may withdraw a proposal within one hundred forty (140) calendar days after the date set for opening bids.**

The right is reserved, as the **Fort Dodge Regional Airport Commission** may require, to reject any and all bids and to waive any informality in the bids received.

All Contractor(s) and subcontractor(s) are required to obtain tax exemption certificates from the **Fort Dodge Regional Airport, Fort Dodge, Iowa** for this project. These tax exemption certificates are only for use on this specific project as covered under the Contract. Before final payment will be made on this project, the Contractor(s) and subcontractor(s) shall provide lien waivers as required in the Specifications.

All work under the contract shall be completed and ready for operation on or before a date to be specified in the “Notice to Proceed”. The Contractor(s) shall fully complete all work, including deliver of the vehicle/equipment **within 90 calendar days** of the date of the “Notice to Proceed” or issued Purchase Order. Deliver shall be free on board (FOB) destination to the address noted herein below. Cash on Delivery (COD) deliveries will not be accepted. All vehicles/equipment shall be off-loaded at the designated location at the vendor’s expense.

Failure to complete the work under the specified schedule will result in liquidated damages of **\$250.00 per calendar day** until the project is complete.

This project is subject to the requirements of 49 CFR Part 26 Disadvantaged Business Enterprise Participation.
