

**NOTICE TO BIDDERS AND  
NOTICE OF PUBLIC HEARING**  
JURISDICTION OF CITY OF ALTOONA PUBLIC IMPROVEMENT PROJECT

Notice is hereby given that a public hearing will be held by the City of Altoona on the proposed contract documents (plans, specifications, and form of contract) and estimated cost for the improvement at its meeting at 6:30 PM, on March 16, 2026, in said City Hall, 900 Venbury Drive, Altoona for the 42nd STREET NW RECONSTRUCTION RISE project.

Sealed bids for the work comprising each improvement as stated below must be filed before 2:00 PM, according to the clock the office of City Clerk, 900 Venbury Drive, Altoona on Tuesday, March 3, 2026, in the office of the City Clerk. Bids received after the deadline for submission of bids as stated herein shall not be considered and shall be returned to the late bidder unopened.

Sealed proposals will be opened and bids tabulated at 2:00 PM on Tuesday, March 3, 2026 in the office of the City Clerk for consideration by the City of Altoona at its meeting on March 16, 2026.

Work on the improvement shall be commenced immediately upon approval of the contract by the City Council, and be completed as stated below.

A virtual pre-letting conference will be held on February 18, 2026 at 10:00am. Contact Engineer for additional information. Attendance at the pre-letting conference is not mandatory but is highly recommended.

**This project is subject to Targeted Small Business provisions. Good faith efforts must be made to solicit bids from registered Targeted Small Businesses, as listed in the [TSB directory](#) provided by the [Iowa Economic Development Authority](#). Good faith efforts must be documented on a completed [TSB Pre-Bid Contact Information form](#) and returned with the bid proposal. Failure to return completed forms will result in the bid being deemed non-responsive.**

By virtue of statutory authority, preference will be given to products and provisions grown and coal produced within the State of Iowa, and to Iowa domestic labor, to the extent lawfully required under Iowa statutes.

In accordance with Iowa statutes, a resident bidder shall be allowed a preference as against a nonresident bidder from a state or foreign country if that state or foreign country gives or requires any preference to bidders from that state or foreign country, including but not limited to any preference to bidders, the imposition of any type of labor force preference, or any other form of preferential treatment to bidders or laborers from that state or foreign country. The preference allowed shall be equal to the preference given or required by the state or foreign country in which the nonresident bidder is a resident. In the instance of a resident labor force preference, a nonresident bidder shall apply the same resident labor force preference to a public improvement in this state as would be required in the construction of a public improvement by the state or foreign country in which the nonresident bidder is a resident.

General Nature of the Public Improvement

The Project is located on 42<sup>ND</sup> Street NW and 34<sup>th</sup> Avenue NW in the City of Altoona and unincorporated portions of Polk County. The project includes approximately 7849 CY of Topsoil On-site., 19090 CY of Class 10 Excavation, 21770 SY 12" Subgrade Preparation, 2701 SY of soil stabilization, 21630 SY of 8" thick Modified Subbase, 403 SY of 12" Class A Crushed Stone, 1398 LF of 15" RCP Storm Sewer, 310 LF 18" RCP Storm Sewer, 200 LF 24" RCP Storm Sewer, 264 LF 30" RCP Storm Sewer, 268 LF 54" RCP storm sewer, 8303 LF of 6" Subdrain with cleanouts and connections, 22 pipe aprons of various sizes 15" to 54", 2746 LF 12" PVC Water Main, 106 LF of trenchless 16" PVC Water Main, 3543 LF of 16" PVC C900 water main, 6125 LBS ductile iron water main fittings, 21 water main valves, 20 fire hydrants, 22 SW-505 and SW-506 intakes, 15439 SY 9" PCC Pavement, 1815 SY of HMA base widening, 1112 SY of 6" HMA Shoulder, 120 SY 6" HMA pavement, 520 SY of 6" Granular Driveway, 2536 SY Pavement Removal (HMA), 528 TON of 2" HMA Overlay, 2992 SY of HMA Milling, including profile millings, 1190 SY of 7" and 9" PCC driveway, 136.8 STA Painted Pavement Markings Durable with Groove Cut, 27 Painted Symbols and Legends, Durable with Grooves Cut, 107 Stations of Painted Pavement Markings Solvent/Waterborne, Temporary Traffic Control, 37 Traffic Signs, 19.8 acres of Type 6 and Type 2 Seeding, Fertilizing and Mulching, SWPPP Management and related erosion controls. Bid Alternate A includes 822 LF of 15" PVC Trenched Gravity Sewer, 329 LF of 18" PVC Trenched Gravity Sewer and 4 SW-301 Manholes.

Each bidder shall accompany its bid with bid security as defined in Iowa Code Section 26.8, as security that the successful bidder will enter into a contract for the work bid upon and will furnish after the award of contract a corporate surety bond, in a form acceptable to the Jurisdiction, for the faithful performance of the contract, in an amount equal to 100% of the amount of the contract. The bidder's security shall be in the amount fixed in the Instruction to Bidders and shall be in the form of a cashier's check or a certified check drawn on an FDIC insured bank in Iowa or on an FDIC insured bank chartered under the laws of the United States; or a certified share draft drawn on a credit union in Iowa or chartered under the laws of the United States; or a bid bond on the form provided in the contract documents with corporate surety satisfactory to the Jurisdiction. The bid shall contain no condition except as provided in the specifications.

The City of Altoona reserves the right to defer acceptance of any bid for a period of sixty (60) calendar days after receipt of bids and no bid may be withdrawn during this period.

Each successful bidder will be required to furnish a corporate surety bond in an amount equal to 100% of its contract price. Said bond shall be issued by a responsible surety approved by City of Altoona and shall guarantee the faithful performance of the contract and the terms and conditions therein contained and shall guarantee the prompt payment of all material and labor, and protect and save harmless The City of Altoona from claims and damages of any kind caused by the operations of the contract and shall also guarantee the maintenance of the improvement caused by failures in materials and construction for a period of four years from and after acceptance of the contract.
