**TIME AND PLACE FOR FILING SEALED PROPOSALS:** Sealed proposals for the work described below will be received online through QuestCDN.com until 2:00 PM on February 26, 2026, at which time and place the bids will be opened and publicly read online through Microsoft Teams. The results will be reported to the Iowa Great Lakes Sanitary District at 3:00 P.M. on Tuesday, March 10, 2026, at 303 28th Street, Milford, IA 51351 at which time and place the Board of Trustees will consider the proposals and may take action on the proposals submitted or at such later time as may then be fixed.

**TIME FOR COMMENCEMENT AND COMPLETION OF WORK:** Work on the improvements shall commence upon approval of the contract by the Board of Trustees, and as stated in the Notice to Proceed. Work under the Contract must be substantially complete by June 30, 2026, and complete and ready for final payment in accordance with the contract documents by July 31, 2026. Liquidated damages for work remaining after completion dates are defined in Section 00 52 00.

**BID SECURITY:** A bid security as defined by Iowa Code Chapter 26.8 and in the amount of not less than 5 percent of the total amount bid, drawn in favor of the Iowa Great Lakes Sanitary District, shall accompany each bid.

**PROJECT DESCRIPTION:** The work includes the following:

1. Construction of approximately 4,000 LF of 18" sanitary forcemain , 2,300 LF of 12" sanitary forcemain , 142 LF of 10" sanitary forcemain, and 400 LF of 6" sanitary forcemain. Construction includes 5 air release manholes and 4 maintenance manholes.
2. Construction of approximately 1538 LF of 24" sanitary sewer. Construction includes 7 sanitary manholes.

Together with numerous related items of work, all in accordance with Plans and Specifications.

**BID SUBMITTAL:** A bid shall be submitted online no later than the date and time prescribed. For this project, the Owner will only be accepting online electronic bids through QuestCDN. To access the electronic bid form, download the project document and click online bidding button at the top of the advertisement. Prospective bidders must be on the plan holders list through QuestCDN for bids to be accepted.

**PREFERENCE OF PRODUCTS AND LABOR:** Preference shall be given to domestic construction materials by the contractor, subcontractors, material, men, and suppliers in performance of the contract and further, by virtue of statutory authority, preference will be given to products and provisions grown and coal produced within the State of Iowa, and to Iowa domestic labor, to the extent lawfully required under Iowa statutes. Failure to submit a fully completed Bidder Status Form with the bid may result in the bid being deemed nonresponsive and rejected.

**SALES TAX EXEMPTION:** The bidder shall not include sales tax in the bid. The Iowa Great Lakes Sanitary District will distribute tax exemption certificates and authorization letters to the Contractor and all subcontractors who are identified. The Contractor and subcontractor may make copies of the tax exemption certificates and provide a copy to each supplier providing construction materials. These tax exemption certificates and authorization letters are applicable only for this specific project under the Contract.

**PERFORMANCE, PAYMENT, AND MAINTENANCE BONDS:** Each successful bidder will be required to furnish a corporate surety bond in an amount equal to 100% of its contract price. Said bond shall be issued by a responsible surety and shall guarantee the faithful performance of the contract and the terms and conditions therein contained and shall guarantee the prompt payment of all material and labor, and protect and save harmless the Iowa Great Lakes Sanitary District from claims and damages of any kind caused by the operations of the contract and shall also guarantee the maintenance of the improvement caused by failures in materials and construction for a period of two years from and after acceptance of the contract.

The Bid, Agreement, and Bonds shall be conditioned upon compliance with all provisions of the Bid Documents.

**OWNER'S RIGHTS RESERVED:** The Owner reserves the right to reject any or all bids and to waive any irregularities and informalities therein and to award the Contract to other than the lowest bidder if, in their discretion, the interest of the Owner would be best served thereby.
