Online bids for the construction of certain **City of Chariton, Iowa** improvements and work incidental thereto on an improvement project described in general as **“Chariton Municipal Airport: Replace Runway 10-28, Taxiway A, and Taxiway B Lighting and NAVAIDS”** must be filed before 11:00 a.m. on the 9th day of March, 2026, utilizing online bidding through QuestCDN. (EBid Reference No. 9987232), in accordance with the Plans and Specifications now on file at the Terminal Building. At said time and place, Proposals will be opened and tabulated by the Engineer.

Proposals received will be presented to the **City of Chariton, Iowa** and considered at a meeting presided over by the Council, to be held at 115 South Main Street, at 5:00 pm on the 16th of March, 2026. At such time and place, the **City of Chariton, Iowa** shall also hold a Public Hearing on the proposed Plans, Specifications, form of Contract and estimate of cost for the construction of said improvements hereinafter described in accordance with the provisions of Chapter 384, Code of Iowa, at 5:00 PM on the 16th of March, 2026 at 115 South Main Street. At the hearing, the **Chariton City Council** will receive and consider any objections made by any interested party, to the Plans and Specifications, proposed form of Contract, and the estimate of the cost for the project.

Bid Bond forfeited, and the proceeds retained as liquidated damages if the bidder fails to execute a contract or file acceptable performance bonds or provide an acceptable certificate of insurance within fifteen (15) calendar days after the acceptance of his proposal by resolution of the Authority. No bidder may withdraw a proposal prior to **August 1, 2026**.

The right is reserved, as the **City of Chariton, Iowa** may require, to reject any and all bids and to waive any informality in the bids received.

All Contractor(s) and subcontractor(s) are required to obtain tax exemption certificates from the **City of Chariton, Iowa** for this project. These tax exemption certificates are only for use on this specific project as covered under the Contract. Before final payment is made on this project, the Contractor(s) and subcontractor(s) shall provide lien waivers as required in the Specifications.
