Online bids will be received by the **City of Keokuk, Iowa, on the 11th day of March, 2026, at 1:30 p.m.**, for the construction of certain Keokuk Municipal Airport improvements and work incidental thereto on an improvement project described in general as "**Keokuk Municipal Airport: Reconstruct Taxiway A & D Lighting**" in accordance with the Plans and Specifications now on file in the office of the Public Works Director and available at [www.questcdn.com](http://www.questcdn.com). At said time and place, Proposals will be opened and tabulated by the Engineer.

Proposals received will be presented to the **City of Keokuk** and considered at a meeting presided over by the City Council, to be held at 501 Main Street, **at 5:30 p.m. on the 19th of March, 2026**. At such time and place, the **City of Keokuk** shall also hold a Public Hearing on the proposed Plans, Specifications, form of Contract and estimate of cost for the construction of said improvements hereinafter described in accordance with the provisions of Chapter 384, Code of Iowa, **at 5:30 p.m. on the 19th of March, 2026** at 501 Main Street. At the hearing, the **City of Keokuk** will receive and consider any objections made by any interested party, to the Plans and Specifications, proposed form of Contract, and the estimate of the cost for the project.

Copies of the Plans, Specifications and wage rate are on file and may be inspected at the office of the Public Works Director, **at 501 Main Street, Keokuk, Iowa**. This project will involve the following work improvements:

1. Construction Staking
2. Mobilization
3. Traffic Control
4. Removal Of Existing Lighting And Cable
5. Install New L-861T(L) MITL Lighting On New Bases
6. Install New L-858(L) Guidance Signs
7. Vault Building Modifications
8. Remove And Replace Constant Current Regulator
9. Directional Boring
10. Existing System Protection
11. Seeding And Mulching

All bids must be filed with the **City of Keokuk** on or before the time herein set. All bids must be on file on QuestCDN.com on or before the time herein set. Each bid shall be accompanied by a Bid Bond in an amount equal to five (5%) of the total amount of the bid. Bid Bonds must be on the form provided with the Contract Documents. The Certified Check, Certified Share Draft or Cashier's Check shall be drawn on a bank or Credit Union in Iowa or a bank or Credit Union chartered under the laws of the United States of America and payable to the **City of Keokuk** as security that if awarded a contract, the bidder will enter into a contract at the prices bid and furnish the required performance and payment bonds and certificates of Insurance. The Certified Check, Certified Share Draft or Cashier's Check may be cashed, or the Bid Bond forfeited, and the proceeds retained as liquidated damages if the bidder fails to execute a contract or file acceptable performance bonds or provide an acceptable certificate of insurance within fifteen (15) calendar days after the acceptance of his proposal by resolution of the Airport Authority. No bidder may withdraw a proposal until after **September 1, 2026** after the date set for opening bids.

The right is reserved, as **City of Keokuk** may require, to reject any and all bids and to waive any informality in the bids received.

All Contractor(s) and subcontractor(s) are required to obtain tax exemption certificates from the **City of Keokuk, Iowa** for this project. These tax exemption certificates are only for use on this specific project as covered under the Contract. Before final payment will be made on this project, the Contractor(s) and subcontractor(s) shall provide lien waivers as required in the Specifications.

All work of the Contract shall be completed and ready for operation according to the following schedule:
