Online bids for the construction of certain Maquoketa Municipal Airport improvements and work incidental thereto on an improvement project described in general as “**Maquoketa Municipal Airport - Rehabilitate Runway 15-33 (Joint and Crack Seal)**” must be filed before **2:00 p.m. on the 22th day of April, 2026**, utilizing online bidding through QuestCDN. (Ebid Reference No. 10106664), in accordance with the Plans and Specifications now on file in the office of the City Manager and available at www.questcdn.com. At said time and place, Proposals will be opened and tabulated by the Engineer.

Proposals received will be presented to the **City of Maquoketa** and considered at a meeting presided over by the Mayor, to be held in the council chambers at the City of Maquoketa, **City Hall**, 201 East Pleasant Street, Maquoketa, Iowa 52060, at **6:00 p.m. on the 27th of April, 2026**. At such time and place, the **City of Maquoketa** shall also hold a Public Hearing on the proposed Plans, Specifications, form of Contract and estimate of cost for the construction of said improvements hereinafter described in accordance with the provisions of Chapter 384, Code of Iowa, at **6:00 p.m. on the 27th of April, 2026 at the City of Maquoketa, City Hall, 201 East Pleasant Street, Maquoketa, Iowa 52060**. At the hearing, the **City of Maquoketa** will receive and consider any objections made by any interested party, to the Plans and Specifications, proposed form of Contract, and the estimate of the cost for the project.

PROJECT DESCRIPTION: Rehabilitate runway 15-33 pavement including joint cleaning and sealing, crack routing and sealing, and partial depth patching.

All bids must be on file on QuestCDN.com on or before the time herein set. Each bid shall be accompanied by a Bid Bond in an amount equal to five (5%) of the total amount of the bid. Bid Bonds must be on the form provided with the Contract Documents. The Certified Check, Certified Share Draft or Cashier's Check shall be drawn on a bank or Credit Union in Iowa or a bank or Credit Union chartered under the laws of the United States of America and payable to the **City of Maquoketa** as security that if awarded a contract, the bidder will enter into a contract at the prices bid and furnish the required performance and payment bonds and certificates of Insurance. The Certified Check, Certified Share Draft or Cashier's Check may be cashed, or the Bid Bond forfeited, and the proceeds retained as liquidated damages if the bidder fails to execute a contract or file acceptable performance bonds or provide an acceptable certificate of insurance within fifteen (15) calendar days after the acceptance of his proposal by resolution of the **City of Maquoketa**. No bidder may withdraw a proposal **until after September 1, 2026**.

The right is reserved, as the **City of Maquoketa** may require, to reject any and all bids and to waive any informality in the bids received.

All Contractor(s) and subcontractor(s) are required to obtain tax exemption certificates from the **City of Maquoketa, Iowa**, for this project. These tax exemption certificates are only for use on this specific project as covered under the Contract.

Before final payment will be made on this project, the Contractor(s) and subcontractor(s) shall provide lien waivers as required in the Specifications.

All work of the Contract shall be completed and ready for operation according to the following schedule:
