Position: Equipment Operator II

Job Summary:

Intermediate position under general supervision of the Street Supervisor, performs manual labor, semi-skilled and skilled work often involving the operation of light and medium construction and maintenance equipment. Must exhibit average competency in machinery operations.

Job Requirements:

- HS Diploma/GED, or two to three years related experience or training, or associate's degree or equivalent.
- Residency requirements are within a drive time of forty-five minutes of Nevada.
- Available for off-hour emergencies.
- Possession of or ability to obtain Valid Class B CDL with tanker and air brakes endorsement issued by the State of Iowa
- Possession of or ability to obtain Valid Herbicide and Pesticide core category 6 and 7D Certification.
- Performs all duties of an Equipment Operator I/Laborer
- Installs and repairs water, storm, and sewer mains, manholes, intakes and hydrants.
- Operates endloader, backhoe, and grader to remove concrete, snow or other materials from streets.
- Operates trucks, tractors, and other relevant equipment to construct, maintain and repair streets; performs routine maintenance and repair of equipment; performs duties relating to finishing concrete and leveling asphalt.
- Assists with One Call utility locates.
- Ability to follow written, verbal or diagrammatic instructions utilizing several concrete variables.
- Ability to utilize a wide variety of descriptive data and information such as safety regulations, equipment maintenance records, maps, construction sheets, and equipment operating and maintenance manuals.
