General Nature of Public Improvement

Proposed Street Improvements – HMA Resurfacing – Maple Street – Columbus Junction, Iowa – 2026

The project includes milling and HMA resurfacing one block of Maple Street from 2nd Street to Main Street.

Time and Place for Filing Sealed Bids

Sealed bids for the work comprising each improvement as stated above must be filed before 4:30 P.M. on September 23, 2026, in the office of the City Clerk at the City Hall, 232 2nd Street, Columbus Junction, Iowa.

Time and Place Sealed Bids Will Be Opened and Considered.

Sealed bids will be opened and tabulated by the Owner during their meeting beginning at 4:30 PM on September 23rd, 2026 in the Council Chambers at City Hall, 232 2nd Street, Columbus Junction, Iowa. The bids will be considered by the City Council at their meeting beginning at 5:30 on September 23rd, 2026 in the Council Chambers at City Hall.

Time for Commencement and Completion of Work.

The work under the proposed Contract shall commence upon issuance of the written Notice to Proceed. The proposed HMA resurfacing improvements listed shall be fully completed on or before November 20, 2026. The Bidder agrees to pay as liquidated damages the sum of \$500 for each consecutive calendar day after the specified completion date that the project is not fully completed.

Bid Security.

Each bidder shall accompany its bid with bid security as defined in Section 26.8 of the Code of Iowa. Bid security shall be 10% of the bid amount.

Contract Documents.

Drawings and specifications governing the construction of the proposed improvements have been prepared by French-Reneker-Associates, Inc., Engineers and Surveyors, Fairfield, Iowa. Sales Tax.

Iowa sales tax will not be paid on materials purchased for this project. The City will issue a sales tax exemption certificate.
