

SECTION 00100 - NOTICE TO BIDDERS

City Park Pavilion & Restroom Facility

Receipt and Opening of Sealed Proposals. Sealed proposals for the work comprising the repair or improvement as stated below must be filed before 10:00 A.M. on October 6, 2026, in the office of the City Clerk, 120 North Main Avenue, Alburnett, Iowa 52202. Sealed proposals will be opened and publicly read with bids being tabulated at that time. The results will be reported to the City Council of the City of Alburnett at its meeting at 7:00 P.M. on October 8, 2026, at which time the City Council may take action on the proposals submitted or at such time as may then be fixed. The City of Alburnett City Council reserves the right to reject any or all bids, to waive informalities or technicalities in any bid, and to enter into such contract, or contracts, as it shall deem to be in the best interest of the City of Alburnett.

Time for Commencement and Completion of Work. Work on the improvement shall commence no later than April 12, 2027. Contractor shall place order for restroom facility and any other specialty equipment within thirty days of the Notice to Proceed. Proof of order must be provided to the city. All work under the contract must be complete within thirty working days. Liquidated damages are as set forth in Section 00500 – Contract.

Bid Security. Each Bidder shall accompany its bid with bid security, as defined in Iowa Code Section 26.8, as security that the successful Bidder will enter into a contract for the work bid upon. The Bidder's security shall be in an amount equal to 5 percent of the total amount of the bid. The bid shall contain no condition except as provided in the specifications. If the Bidder fails to execute the contract and to furnish an acceptable Performance, Payment, and Maintenance Bond or provide a Certificate of Insurance within ten (10) days after acceptance of the bid by the City, the bid security may be forfeited or cashed by the City as liquidated damages.

Contract Documents. Copies of the project documents are available for a price of \$25.00 per set. This fee is refundable, provided the plans and specifications are returned complete and in reusable condition, and they are returned within fourteen (14) calendar days after the award of the project. Preference of Products and Labor. By virtue of statutory authority, a preference will be given to products and provisions grown and coal produced within the State of Iowa, to the extent lawfully required under Iowa statutes.

Sales Tax Exemption Certificates. The Bidder shall not include sales tax in the bid. The City of Alburnett will distribute tax exemption certificates and authorization letters to the contractor and all subcontractors who are identified. The contractor and subcontractor may make copies of the tax exemption certificates and provide a copy to each supplier providing construction materials. These tax exemption certificates and authorization letters are applicable only for this specific project under the contract.

PROJECT DESCRIPTION: This project consists of all materials, equipment, transportation and labor necessary for the construction of a park pavilion and restroom facility at 405 Roosevelt Street in Alburnett, IA. Work includes the procurement and installation of a pavilion structure, manufactured restroom facility, and concrete pad for the mentioned facilities. Also included in the project is underground utility connections, seeding and erosion control.
