Frontiers Market Terms of Service

Welcome, and thank you for your interest in Frontiers Market Technologies Inc. ("Frontiers Market," (we," or (us') and our website at www.frontiersmarket.com, along with our related downloadable applications, and other services provided by us (collectively, the "Service"). These Terms of Service are a legally binding contract between you and Frontiers Market regarding your use of the Service.

PLEASE READ THE FOLLOWING TERMS CAREFULLY:

BY CLICKING "I ACCEPT," OR BY DOWNLOADING, INSTALLING, OR OTHERWISE ACCESSING OR USING THE SERVICE, YOU AGREE THAT YOU HAVE READ AND UNDERSTOOD, AND, AS A CONDITION TO YOUR USE OF THE SERVICE, YOU AGREE TO BE BOUND BY, THE FOLLOWING TERMS AND CONDITIONS, INCLUDING FRONTIERS MARKET'S PRIVACY POLICY https://frontiersmarket.com/terms-of-service (TOGETHER, THESE "TERMS"). IF YOU ARE NOT ELIGIBLE, OR DO NOT AGREE TO THE TERMS, THEN YOU DO NOT HAVE OUR PERMISSION TO USE THE SERVICE. YOUR USE OF THE SERVICE, AND FRONTIERS MARKET'S PROVISION OF THE SERVICE TO YOU, CONSTITUTES AN AGREEMENT BY FRONTIERS MARKET AND BY YOU TO BE BOUND BY THESE TERMS.

YOU AGREE TO RECEIVE TEXTS FROM OR ON BEHALF OF FRONTIERS MARKET AT THE PHONE NUMBER YOU PROVIDE TO US. THESE TEXTS MAY INCLUDE OPERATIONAL AND MARKETING MESSAGES. YOU UNDERSTAND AND AGREE THAT THESE TEXTS MAY BE CONSIDERED TELEMARKETING UNDER APPLICABLE LAW, THEY MAY BE SENT USING AN AUTOMATIC TELEPHONE DIALING SYSTEM OR OTHER AUTOMATED TECHNOLOGY, AND YOUR CONSENT IS NOT A CONDITION OF ANY PURCHASE.

ARBITRATION NOTICE. Except for certain kinds of disputes described in Section 18 (*Dispute Resolution and Arbitration*), you agree that disputes arising under these Terms will be resolved by binding, individual arbitration, and BY ACCEPTING THESE TERMS, YOU AND FRONTIERS MARKET ARE EACH WAIVING THE RIGHT TO A TRIAL BY JURY OR TO PARTICIPATE IN ANY CLASS ACTION OR REPRESENTATIVE PROCEEDING.

- 1. Frontiers Market Service Overview. Frontiers Market offers an online marketplace for users to sell and purchase livestock at auction. Our downloadable mobile application may also include software powered by artificial intelligence that enables you to weigh your cattle using only your smartphone (the "AI Cattle Scale").
- **2. Eligibility**. You must be at least 18 years old to use the Service. By agreeing to these Terms, you represent and warrant to us that: (a) you are at least 18 years old; (b) you have not previously been suspended or removed from the Service; and (c) your registration and your use of the Service is in compliance with any and all applicable laws and regulations. If you are an entity, organization, or company, the individual accepting these Terms on your behalf represents and warrants that they have authority to bind you to these Terms and you agree to be bound by these Terms.
- 3. Accounts and Registration. To access most features of the Service, you must register for an account. When you register for an account, you may be required to provide us with some information about yourself, such as your name, email address, phone number, mailing address, and or other contact information. You agree that the information you provide to us is accurate, complete, and not misleading, and that you will keep it accurate and up to date at all times. When you register, you will be asked to create a password. You are solely responsible for maintaining the confidentiality of your account and password, and you accept responsibility for all activities

that occur under your account. If you believe that your account is no longer secure, then you should immediately notify us at contact@frontiersmarket.com.

- **4. General Payment Terms**. Certain features of the Service may require you to pay fees. Before you pay any fees, you will have an opportunity to review and accept the fees that you will be charged. Unless otherwise specifically provided for in these Terms, all fees are in U.S. Dollars and are non-refundable, except as required by law.
- 4.1 **Price**. Frontiers Market reserves the right to determine pricing for the Service. Frontiers Market will make reasonable efforts to keep pricing information published on the Service up to date. We encourage you to check our pricing page periodically for current pricing information. Frontiers Market may change the fees for any feature of the Service, including additional fees or charges, if Frontiers Market gives you advance notice of changes before they apply. Frontiers Market, at its sole discretion, may make promotional offers with different features and different pricing to any of Frontiers Market's customers. These promotional offers, unless made to you, will not apply to your offer or these Terms.
- 4.2 Authorization. You authorize Frontiers Market to charge all sums for the orders that you make and any level of Service you select as described in these Terms or published by Frontiers Market, including all applicable taxes, to the payment method specified in your account. If you pay any fees with a credit card, then Frontiers Market may seek pre-authorization of your credit card account prior to your purchase to verify that the credit card is valid and has the necessary funds or credit available to cover your purchase.
- 5. Buying & Selling Cattle on the Service.
- FAQs. For more details on how Auctions (defined below) work on the Service, including relevant terminology, and your obligations as either a Buyer or Seller (defined below), please visit our FAQs available at www.frontiersmarket.com/term-of-service you acknowledge and agree that the FAQs are hereby incorporated by reference and made part of these Terms.
- 5.2 **Obligations of Sellers.** By listing cattle for sale on the Service (each listing an "<u>Auction</u>"), you (as the "<u>Seller</u>") are making a binding offer to sell the cattle included in the Auction to the individual or entity who has rightfully placed the highest bid at the end of the Auction (the "<u>Buyer</u>"), and you agree to sell such cattle to the Buyer for an amount equal to the winning bid of the Auction, not including any applicable taxes or other associated fees (the "<u>Sale Price</u>").
- Obligations of Bidders. By placing a bid on an Auction, you (as the "Bidder") are making a binding offer to purchase the cattle included in such Auction if your bid is the highest bid at the close of such Auction (the "Winning Bid"). If you are the Buyer, you agree to pay (i) the Sale Price plus any applicable taxes related thereto, and (ii) any additional fees for delivery of the cattle as agreed upon between you and the Seller after the close of the Auction (the "Buyer Fees"). For clarity, delivery fees are not included in the Sale Price.
- 5.4 **Bidding Notifications.** We will use commercially reasonable efforts to notify you at the email you provided to create your account on the Service: (i) if you are a Bidder and your bid on a particular Auction has been outbid; (ii) if you have the Winning Bid at the end of an Auction; and (iii) if you are a Seller and your Auction has ended. You agree that, if any email sent to an email address you

have registered with the Service is rejected as undeliverable, then all notice obligations that we may have to you are hereby void. You are solely responsible for ensuring that your email address remains current.

- Post-Auction Process. All sales are final at the close of an Auction. The Buyer must contact the Seller within seven (7) calendar days after the end of an Auction to arrange for payment and delivery of the applicable cattle. The Buyer agrees to pay the Buyer Fees, and the Seller agrees to deliver the applicable cattle, in each case in accordance with the terms mutually agreed upon between the Buyer and Seller.
- 5.6 **Payment Process.** Payments are not processed on the Service Buyers and Sellers are solely responsible for arranging for payment and delivery between themselves. You hereby acknowledge and agree that (i) Frontiers Market disclaims all liability arising from or in connection with any Auction, and (ii) if you are a party to any dispute related to an Auction, you will not seek damages from Frontiers Market in connection with such dispute.
- 5.7 **Fees Owed to Frontiers Market**. Upon the close of a successful Auction, Frontiers Market charges both the Buyer and Seller a fee equal to 2% of the Sale Price (the "<u>Auction Fee</u>"). You, as either the Buyer or the Seller, agree to pay Frontiers Market the Auction Fee within 5 days after the end of a successful Auction via the payment processing functionality included on the Service.
- 5.8 **Termination of Auctions.** You hereby acknowledge and Agree that Frontiers Market may, in its sole and absolute discretion, terminate an Auction at any time prior to the close of such Auction upon notice to the Seller and any Bidders who have participated in such Auction.

6. Licenses

- 6.1 **Limited License**. Subject to your complete and ongoing compliance with these Terms, Frontiers Market grants you, solely for your personal use, a limited, non-exclusive, non-transferable, non-sublicensable, revocable license to: (a) install and use one object code copy of any mobile or other downloadable application associated with the Service (whether installed by you or pre-installed on your mobile device by the device manufacturer or a wireless telephone provider) on a mobile device that you own or control; and (b) access and use the Service.
- 6.2 **License Restrictions**. Except and solely to the extent such a restriction is impermissible under applicable law, you may not: (a) reproduce, distribute, publicly display, publicly perform, or create derivative works of the Service; (b) make modifications to the Service; or (c) interfere with or circumvent any feature of the Service, including any security or access control mechanism. If you are prohibited under applicable law from using the Service, then you may not use it.
- 6.3 **Feedback**. We respect and appreciate the thoughts and comments from our users. If you choose to provide input and suggestions regarding existing functionalities, problems with or proposed modifications or improvements to the Service ("**Feedback**"), then you hereby grant Frontiers Market an unrestricted, perpetual, irrevocable, non-exclusive, fully-paid, royalty-free right and license to exploit the Feedback in any manner and for any purpose, including to improve the Service and create other products and services. We will have no obligation to provide you with attribution for any Feedback you provide to us.
- 7. Ownership; Proprietary Rights. The Service is owned and operated by Frontiers Market. The

visual interfaces, graphics, design, compilation, information, data, computer code (including source code or object code), products, software, services, and all other elements of the Service provided by Frontiers Market ("<u>Materials</u>") are protected by intellectual property and other laws. All Materials included in the Service are the property of Frontiers Market or its third-party licensors. Except as expressly authorized by Frontiers Market, you may not make use of the Materials. There are no implied licenses in these Terms and Frontiers Market reserves all rights to the Materials not granted expressly in these Terms.

8. Third-Party Terms

- 8.1 Third-Party Services and Linked Websites. Frontiers Market may provide tools through the Service that enable you to export information, including User Content, to third-party services. By using one of these tools, you hereby authorize that Frontiers Market to transfer that information to the applicable third-party service. Third-party services are not under Frontiers Market's control, and, to the fullest extent permitted by law, Frontiers Market is not responsible for any third-party service's use of your exported information. The Service may also contain links to third-party websites. Linked websites are not under Frontiers Market's control, and Frontiers Market is not responsible for their content. Please be sure to review the terms of use and privacy policy of any third-party services before you share any User Content or information with such third-party services. Once sharing occurs, Frontiers Market will have no control over the information that has been shared.
- 8.2 **Third-Party Software**. The Service may include or incorporate third-party software components that are generally available free of charge under licenses granting recipients broad rights to copy, modify, and distribute those components ("**Third-Party Components**"). Although the Service is provided to you subject to these Terms, nothing in these Terms prevents, restricts, or is intended to prevent or restrict you from obtaining Third-Party Components under the applicable third-party licenses or to limit your use of Third-Party Components under those third-party licenses.

9. User Content and Data

- 9.1 **User Content Generally**. Certain features of the Service may permit users to submit, upload, publish, broadcast, or otherwise transmit ("Post") content to the Service, including photos, videos, audio (including sound or voice recordings and musical recordings embodied in the video or audio), images, folders, messages, reviews, data, text, and any other works of authorship or other works ("User Content"). - 9.2 **Limited License Grant to Frontiers Market**. By Posting User Content to or via the Service, you grant Frontiers Market a worldwide, non-exclusive, irrevocable, royalty-free, fully paid right and license (with the right to sublicense through multiple tiers) to host, store, transfer, publicly display, publicly perform (including by means of a digital audio transmission), communicate to the public, reproduce, modify for the purpose of formatting for display, create derivative works as authorized in these Terms, and distribute your User Content, in whole or in part, in any media formats and through any media channels, in each instance whether now known or hereafter developed. You agree to pay all monies owing to any person or entity resulting from Posting your User Content and from Frontiers Market's exercise of the license set forth in this Section.

- 9.3 **Specific Rules for Photographs and Images**. If you Post a photograph or image to the Service that includes one or more persons, you hereby grant such persons and their administrators, guardians, heirs, and trustees, if any, an irrevocable, perpetual, royalty free, fully paid-up, worldwide license to reproduce, distribute, and publicly display that photograph for personal use and through any online platform or service, including the Service, Facebook, Instagram, and Twitter, but not to promote any third-party product, good, or service. The license contained in this Section does not permit the subject of any photo or their administrators, guardians, heirs, or trustees to sell that image or photograph, whether on a standalone basis or as embodied in any product.
- 9.4 You Must Have Rights to the Content You Post; User Content Representations and Warranties. You must not Post User Content if you are not the owner of or are not fully authorized to grant rights in all of the elements of that User Content, including in all ambient music and underlying musical works embodied in any sound recording. Frontiers Market disclaims any and all liability in connection with User Content. You are solely responsible for your User Content and the consequences of providing User Content via the Service. By providing User Content via the Service, you affirm, represent, and warrant to us that:
 - (a) you are the creator and owner of the User Content, or have the necessary licenses, rights,
 - consents, and permissions to authorize Frontiers Market and users of the Service to use and distribute your User Content as necessary to exercise the licenses granted by you in this Section, in the manner contemplated by Frontiers Market, the Service, and these Terms;
 - (b) your User Content, and the Posting or other use of your User Content as contemplated by these Terms, does not and will not: (i) infringe, violate, misappropriate, or otherwise breach any third-party right, including any copyright, trademark, patent, trade secret, moral right, privacy right, right of publicity, or any other intellectual property, contract, or proprietary right; (ii) slander, defame, libel, or invade the right of privacy, publicity or other property rights of any other person; or (iii) cause Frontiers Market to violate any law or regulation or require us to obtain any further licenses from or pay any royalties, fees, compensation or other amounts or provide any attribution to any third parties; and
 - (c) your User Content could not be deemed by a reasonable person to be objectionable,
 - profane, indecent, pornographic, harassing, threatening, embarrassing, hateful, or otherwise inappropriate.
- 9.5 **User Content Disclaimer**. We are under no obligation to edit or control User Content that you or other users Post and will not be in any way responsible or liable for User Content. Frontiers Market may, however, at any time and without prior notice, screen, remove, edit, or block any User Content that in our sole judgment violates these Terms, is alleged to violate the rights of third parties, or is otherwise objectionable. You understand that, when using the Service, you will be exposed to User Content from a variety of sources and acknowledge that User Content may be inaccurate, offensive, indecent, or objectionable. You agree to waive, and do waive, any legal or equitable right or remedy you have or may have against Frontiers Market with respect to User Content. If notified by a user or content owner that User Content allegedly does not conform to

these Terms, we may investigate the allegation and determine in our sole discretion whether to remove the User Content, which we reserve the right to do at any time and without notice. For clarity, Frontiers Market does not permit infringing activities on the Service.

- 9.6 **Monitoring Content**. Frontiers Market does not control and does not have any obligation to monitor: (a) User Content; (b) any content made available by third parties; or (c) the use of the Service by its users. You acknowledge and agree that Frontiers Market reserves the right to, and may from time to time, monitor any and all information transmitted or received through the Service for operational and other purposes. If at any time Frontiers Market chooses to monitor the content, then Frontiers Market still assumes no responsibility or liability for content or any loss or damage incurred as a result of the use of content. During monitoring, information may be examined, recorded, copied, and used in accordance with our Privacy Policy (defined below). Frontiers Market may block, filter, mute, remove or disable access to any User Content uploaded to or transmitted through the Service without any liability to the user who Posted such User Content to the Service or to any other users of the Service.
- 9.7 **Captured Data.** If, and to the extent the Service is used to Post data with respect to cattle collected by Frontiers Market using audio/video/photo capture equipment placed by Frontiers Market on your property for the purpose of capturing such data ("**Captured Data**"), you acknowledge and agree that all Captured Data is owned solely by Frontiers Market.
- 9.8 **Aggregated Data**. Notwithstanding any other provision to the contrary in, and without limiting the generality of, these Terms, Subscriber agrees that Frontiers Market may use the anonymized aggregated User Content and Captured Data without restriction for any purpose including for the purposes of statistical analysis, development and/or marketing of a benchmarking database and for promotional purposes. All data compiled by Frontiers Market pursuant to this Section 9.8 shall be deemed to be owned by Frontiers Market for all purposes.

10. Communications

- 10.1 **Text Messaging**. You agree that Frontiers Market and those acting on our behalf may send you text (SMS) messages at the phone number you provide us. These messages may include operational messages about your use of the Service, as well as marketing messages. Text messages may be sent using an automatic telephone dialing system. Standard data and message rates may apply whenever you send or receive such messages, as specified by your carrier. IF YOU WISH TO OPT OUT OF MARKETING TEXT MESSAGES FROM FRONTIERS MARKET, YOU CAN EMAIL CONTACT@FRONTIERSMARK.COM OR TEXT THE WORD "STOP" TO THE NUMBER FROM WHICH YOU ARE RECEIVING THE MESSAGES. IF YOU WISH TO OPT OUT OF ALL TEXT MESSAGES FROM FRONTIERS MARKET, YOU CAN EMAIL CONTACT@FRONTIERSMARK.COM OR TEXT THE WORD "STOPALL" TO THE NUMBER FROM WHICH YOU ARE RECEIVING THE MESSAGES, HOWEVER YOU ACKNOWLEDGE THAT OPTING OUT OF RECEIVING ALL MESSAGES MAY IMPACT YOUR USE OF THE SERVICE. You may continue to receive text messages for a short period while we process your request, including a message confirming the receipt of your opt-out request. Your agreement to receive marketing texts is not a condition of any purchase on or use of the Service.
- 10.2 **Push Notifications**. When you install our app on your mobile device, you agree to receive push notifications, which are messages an app sends you on your mobile device when you are not in the app. You can turn off notifications by visiting your mobile device's "settings" page.

- 10.3 **Email**. We may send you emails concerning our products and services, as well as those of third parties. You may opt out of promotional emails by following the unsubscribe instructions in the promotional email itself.
- **11. Prohibited Conduct**. BY USING THE SERVICE, YOU AGREE NOT TO:
- use the Service for any illegal purpose or in violation of any local, state, national, or international law;
- 11.2 harass, threaten, demean, embarrass, bully, or otherwise harm any other user of the Service;
- violate, encourage others to violate, or provide instructions on how to violate, any right of a third party, including by infringing or misappropriating any third-party intellectual property right;
- 11.4 manipulate the price of any Auction or otherwise interfere with any Auction;
- 11.5 Post false, inaccurate, misleading, deceptive, defamatory, or libelous content;
- 11.6 access, search, or otherwise use any portion of the Service through the use of any engine, software, tool, agent, device, or mechanism (including spiders, robots, crawlers, and data mining tools) other than the software or search agents provided by Frontiers Market;
- interfere with security-related features of the Service, including by: (i) disabling or circumventing features that prevent or limit use, printing or copying of any content; or (ii) reverse engineering or otherwise attempting to discover the source code of any portion of the Service except to the extent that the activity is expressly permitted by applicable law;
- interfere with the operation of the Service or any user's enjoyment of the Service, including by:
 (i) uploading or otherwise disseminating any virus, adware, spyware, worm, or other malicious code; (ii) making any unsolicited offer or advertisement to another user of the Service; (iii) collecting personal information about another user or third party without consent; or (iv) interfering with or disrupting any network, equipment, or server connected to or used to provide the Service;
- 11.9 perform any fraudulent activity including impersonating any person or entity, claiming a false affiliation or identity, accessing any other Service account without permission, or falsifying your age or date of birth;
- 11.10 sell or otherwise transfer the access granted under these Terms or any Materials (as defined in Section 7 (*Ownership; Proprietary Rights*)) or any right or ability to view, access, or use any Materials; or
- attempt to do any of the acts described in this Section 11 (*Prohibited Conduct*) or assist or permit any person in engaging in any of the acts described in this Section 11 (*Prohibited Conduct*).
- 12. Intellectual Property Rights Protection
- 12.1 Respect of Third Party Rights. Frontiers Market respects the intellectual property rights of others,

takes the protection of intellectual property rights very seriously, and asks users of the Service to do the same. Infringing activity will not be tolerated on or through the Service.

12.2 **DMCA Notification**. We comply with the provisions of the Digital Millennium Copyright Act applicable to Internet service providers (17 U.S.C. § 512, as amended). 12.3 **Procedure for Reporting Claimed Infringement**. If you believe that any content made available on or through the Service has been used or exploited in a manner that infringes an intellectual property right you own or control, then please promptly send a written "Notification of Claimed"

(a) an electronic or physical signature of the person authorized to act on behalf of the owner of the copyright or other right being infringed;

Infringement" to the Designated Agent identified above containing the following information:

(b) a description of the copyrighted work or other intellectual property right that you claim

has been infringed;

- (c) a description of the material that you claim is infringing and where it is located on the Service;
- (d) your address, telephone number, and email address;
- (e) a statement by you that you have a good faith belief that the use of the materials on the Service of which you are complaining is not authorized by the copyright or other

intellectual property right owner, its agent, or the law; and

(f) a statement by you that the above information in your notice is accurate and that, under penalty of perjury, you are the copyright or other intellectual property right owner or

authorized to act on the copyright or intellectual property owner's behalf.

Your Notification of Claimed Infringement may be shared by Frontiers Market with the user alleged to have infringed a right you own or control as well as with the operators of publicly available databases that track notifications of claimed infringement, and you consent to Frontiers Market making such disclosures. You should consult with your own lawyer or see 17 U.S.C. § 512 to confirm your obligations to provide a valid notice of claimed infringement.

12.4 **Repeat Infringers**. Frontiers Market's policy is to: (a) remove or disable access to material that Frontiers Market believes in good faith, upon notice from an intellectual property rights owner or authorized agent, is infringing the intellectual property rights of a third party by being made

available through the Service; and (b) in appropriate circumstances, to terminate the accounts of and block access to the Service by any user who repeatedly or egregiously infringes other people's copyright or other intellectual property rights. Frontiers Market will terminate the accounts of users that are determined by Frontiers Market to be repeat infringers. Frontiers Market reserves the right, however, to suspend or terminate accounts of users in our sole discretion.

- 12.5 **Counter Notification**. If you receive a notification from Frontiers Market that material made available by you on or through the Service has been the subject of a Notification of Claimed Infringement, then you will have the right to provide Frontiers Market with what is called a "Counter Notification." To be effective, a Counter Notification must be in writing, provided to Frontiers Market's Designated Agent through one of the methods identified in Section 12.2 (DMCA Notification), and include substantially the following information:
 - (a) your physical or electronic signature;
 - (b) identification of the material that has been removed or to which access has been disabled and the location at which the material appeared before it was removed or access to it was disabled:
 - (c) a statement under penalty of perjury that you have a good faith belief that the material was removed or disabled as a result of mistake or misidentification of the material to be removed or disabled; and
 - (d) your name, address, and telephone number, and a statement that you consent to the jurisdiction of Federal District Court for the judicial district in which the address is located, or if you are residing outside of the United States, then for any judicial district in which Frontiers Market may be found, and that you will accept service of process from the person who provided notification under Section 12.2 (DMCA Notification) above or an agent of that person.

A party submitting a Counter Notification should consult a lawyer or see 17 U.S.C. § 512 to confirm the party's obligations to provide a valid counter notification under the Copyright Act.

- 12.6 Reposting of Content Subject to a Counter Notification. If you submit a Counter Notification to Frontiers Market in response to a Notification of Claimed Infringement, then Frontiers Market will promptly provide the person who provided the Notification of Claimed Infringement with a copy of your Counter Notification and inform that person that Frontiers Market will replace the removed User Content or cease disabling access to it in 10 business days, and Frontiers Market will replace the removed User Content and cease disabling access to it not less than 10, nor more than 14, business days following receipt of the Counter Notification, unless Frontiers Market's Designated Agent receives notice from the party that submitted the Notification of Claimed Infringement that such person has filed an action seeking a court order to restrain the user from engaging in infringing activity relating to the material on Frontiers Market's system or network.
- 12.7 **False Notifications of Claimed Infringement or Counter Notifications**. The Copyright Act provides at 17 U.S.C. § 512(f) that: "[a]ny person who knowingly materially misrepresents under [Section 512 of the Copyright Act (17 U.S.C. § 512)] (1) that material or activity is infringing, or (2) that material or activity was removed or disabled by mistake or misidentification, will be liable for any damages, including costs and attorneys' fees, incurred by the alleged infringer, by any copyright

- 13. Modification of Terms. We may, from time to time, change these Terms. Please check these Terms periodically for changes. Revisions will be effective immediately except that, for existing users, material revisions will be effective 30 days after posting or notice to you of the revisions unless otherwise stated. We may require that you accept modified Terms in order to continue to use the Service. If you do not agree to the modified Terms, then you should remove your User Content and discontinue your use of the Service. Except as expressly permitted in this Section 13 (Modification of Terms), these Terms may be amended only by a written agreement signed by authorized representatives of the parties to these Terms.

- 18.2 **Exceptions**. Although we are agreeing to arbitrate most disputes between us, nothing in these Terms will be deemed to waive, preclude, or otherwise limit the right of either party to: (a) bring an individual action in small claims court; (b) pursue an enforcement action through the applicable federal, state, or local agency if that action is available; (c) seek injunctive relief in a court of law in aid of arbitration; or (d) to file suit in a court of law to address an intellectual property infringement claim.
- 18.3 **Opt-Out**. If you do not wish to resolve disputes by binding arbitration, you may opt out of the provisions of this Section 18 (*Dispute Resolution and Arbitration*) within 30 days after the date that you agree to these Terms by sending a letter to Frontiers Market Technologies Inc., Attention: Legal Department Arbitration Opt-Out, 115 E 5th St, Austin, TX 78701 that specifies: your full legal name, the email address associated with your account on the Service, and a statement that you wish to opt out of arbitration ("**Opt-Out Notice**"). - Arbitrator. The JAMS Rules and filing forms are available online at www.jamsadr.com, by calling the JAMS at +1-800-352-5267 or by contacting Frontiers Market.
- 18.5 Commencing Arbitration. Before initiating arbitration, a party must first send a written notice of the dispute to the other party by certified U.S. Mail or by Federal Express (signature required) or, only if that other party has not provided a current physical address, then by electronic mail ("Notice of Arbitration"). Frontiers Market's address for Notice is: Frontiers Market Technologies Inc., 115 E 5th St, Austin, TX 78701. The Notice of Arbitration must: (a) identify the name or account number of the party making the claim; (b) describe the nature and basis of the claim or dispute; and (c) set forth the specific relief sought ("Demand"). The parties will make good faith efforts to resolve the claim directly, but if the parties do not reach an agreement to do so within 30 days after the Notice of Arbitration is received, you or Frontiers Market may commence an arbitration proceeding. If you commence arbitration in accordance with these Terms, Frontiers Market will reimburse you for your payment of the filing fee, unless your claim is for more than US\$10,000 or if Frontiers Market has received 25 or more similar demands for arbitration, in which case the payment of any fees will be decided by the JAMS Rules. If the arbitrator finds that either the substance of the claim or the relief sought in the Demand is frivolous or brought for an improper purpose (as measured by the standards set forth in Federal Rule of Civil Procedure 11(b)), then the payment of all fees will be governed by the JAMS Rules and the other party may seek reimbursement for any fees paid to JAMS.
- Arbitration Proceedings. Any arbitration hearing will take place in the county and state of your residence unless we agree otherwise or, if the claim is for US\$10,000 or less (and does not seek injunctive relief), you may choose whether the arbitration will be conducted: (a) solely on the basis of documents submitted to the arbitrator; (b) through a telephonic or video hearing; or (c)

by an in-person hearing as established by the JAMS Rules in the county (or parish) of your residence. During the arbitration, the amount of any settlement offer made by you or Frontiers Market must not be disclosed to the arbitrator until after the arbitrator makes a final decision and award, if any.
