Low Severity Issues

1. Safe math

Issue:

• Solidity version acceptable for the contract is ">=0.6.0 <0.9.0", if Solidity version would be lower than 0.8.0, then code blocks without safe math could fail (if there will be inappropriate values).

Recommendation:

Fix solidity version from actual value, not the old one.

2. Values mismatch

Issue:

 maxTxAmountUI is not show actual _maxTxAmount after calling setMaxTxPercent() function.

Recommendation:

Equalize values to show the real value.

Notes:

• After sniper caught, transfer function goes further as usual.

Owner privileges (In the period when the owner is not renounced)

- Owner can migrate the Owner.
- Owner can change router and pair addresses.
- Owner can change _liqAddStatus and _initialLiquidityAmount.
- Owner can remove sniper.
- Owner can change protections settings.
- Owner can change snipeBlockAmt and gasPriceLimit.
- Owner can change fees and ratios.
- Owner can change swap settings.
- Owner can change marketing and ecosystem wallets.
- Owner can exclude from the fees.
- Owner can whitelist accounts.
- Owner can enable trading.

Smart contracts contain low severity issues! Liquidity pair contract's security is not checked due to out of scope.
