## PARTICIPATION

**01**



This competition ("Competition") is conducted by ESC Operations Pty Ltd trading as Upstreet (Upstreet), ABN 88 635 424 538, of 5 Milpera Rtt, Noosa Heads QLD 4567 ("Promoter").

**02**



Entry to the Competition constitutes acceptance of these conditions.

**03**



The Competition is only open to Eligible Entrants. An "Eligible Entrant" is an individual who, at the time of entry:

- a. Is a resident of QLD, NSW, ACT, VIC, TAS, WA or SA within Australia and is aged 18 years or older,
- b. Is not an employee of the Promoter or any of its related corporations or any of their agencies associated with the Competition; and
- c. Is not a spouse, de-facto spouse, parent, child or sibling (whether full, half, step or by adoption) of such an employee.

**04** The Competition is open for entry during the Entry Period. All times and dates are times and dates in Sydney, Australia. The Entry Period is as follows:

**Entry Opens Date: March 28th, 2022**

**Entry Closes Time: 11:59 PM (AEST)**

**Entry Closes Date: April 17th, 2022, ("Entry Period").**



## ENTRY

### 01

To enter, an Eligible Entrant must complete the following requirements for one entry into the Competition:

- a. Before or during the Entry Period, successfully sign up to an Upstreet account and complete the sign-up process including verification of email and 'Know Your Customer' verification as requested by the Promoter;
- b. Before or during the Entry Period, link an eligible Visa or Mastercard debit or credit card and/or bank account to the Eligible Entrant's Upstreet account within the Upstreet app;
- c. After completing the requirement set out in paragraph 5.b, and during the Entry Period, complete a purchase with Marley Spoon using:
  - i. Where the Eligible Entrant has linked a Visa or Mastercard debit or credit card under paragraph 5.b above, that linked card; or
  - ii. Where the Eligible Entrant has linked a bank account under paragraph 5.b above, a credit or debit card associated with that linked bank account,
- d. in either case which entitles the Eligible Entrant to fractional share rewards in the 'Marley Spoon Investment Option' through Upstreet.

### 02

Eligible Entrants may enter multiple times. Each transaction completed in accordance with paragraph 1.b above with entitle the Eligible Entrant with one entry into the Competition.

### 03

An Eligible Entrant will not meet the requirements of paragraph 1.b where the purchase with Marley Spoon is completed using Paypal. For clarity, Paypal purchases have been excluded due to technical issues in recognising the transaction.

### 04

The Promoter takes no responsibility for any late entries or for any delays or failures in any telecommunications service or equipment.

### 05

This is a game of chance and skill plays no part in determining the winners. The winner will be chosen at random. The winner will be notified via email by Upstreet after the Entry Period.

## ENTRY

### 06

All entrants must ensure that their entry is received by the Promoter during the Entry Period. The Promoter takes no responsibility for any late or misdirected entry or for any delays or failures in any telecommunications service or equipment.

### 07

All entries to the Competition may be subject to verification by the Promoter. An entrant must deliver to the Promoter (by a means determined by the Promoter) copies of any documents the Promoter may request establishing eligibility to enter or win, including evidence of age, residence or identity. The Promoter may make one or more requests for such documents. Once the identity of documents available is established, an entrant must deliver requested copies within 7 days of being asked to do so. At the Promoter's request, an entrant must also, within 7 days of being asked, allow the Promoter to inspect and copy the original of any such document

### 08

The Promoter may, at its absolute discretion, declare any or all entries made by an entrant invalid if the entrant:

- a. fails to establish their entitlement to enter the Competition to the Promoter's reasonable satisfaction; or
- b. fails to produce items as required by condition nine (9) or produces items that, in the Promoter's reasonable opinion, are illegible, stolen, forged, reconstructed, altered, incomplete or tampered with in any way; or
- c. in the Promoter's reasonable opinion, tampers with the entry process or benefits from such tampering; or
- d. in the Promoter's reasonable opinion, submits an entry which is not in accordance with these conditions.



## WINNER AND PRIZE

**01** The total prize pool value is **\$3000** and is not transferable or exchangeable and cannot be taken as cash, unless otherwise specified.



There will be one winner selected to win a total prize of **\$3000** in fractional share rewards, which will be applied to the winner's investment in the Upstreet Fund as fractional share rewards in the Marley Spoon investment option.

**02** The Promoter's decision is final and no correspondence will be entered into.



**03** If for any reason a winner does not take a prize (or an element of the prize) because of refusal to accept the prize or by the time stipulated by the Promoter, then the prize (or that element of the prize) will be forfeited and/or the Promoter may elect to redraw the winner of the prize from the remaining entries.



**04** If any prize (or part of any prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize (or that part of the prize) with a prize to the equal value and/or specification.



**05** In order to be entitled to the prize, the winner must, if requested by the Promoter, agree to and sign an eligibility form confirming their compliance with the Conditions and eligibility to accept the prize. The winner will forfeit his/her prize if he/she fails to ensure that all documents relating to that prize are signed in accordance with this condition and returned to the Promoter, as and when required by the Promoter.



## PRIVACY



Entrants' personal information will be collected by or on behalf of the Promoter to enable it to administer the Competition and publicise the winner and, if an entrant consents, may be used to market its products to the entrant. The personal information of the winner may be provided to others assisting in the conduct of the Competition, including the Competition administrator, prize suppliers and deliverers, and to regulatory authorities. If an entrant does not provide accurate personal information the Promoter may determine that they are not eligible to win a prize.
