There is a \$25 enrollment fee for each child. If I choose to withdraw my child, the enrollment fee is non-refundable and an additional enrollment fee will be required to enroll at a later date. Re-enrollment will be subject to availability of history, space, payment history, satisfactory payment of balance due and approval by the Child Care Coordinator. The \$125 summer activity fee must be paid by March 10, 2026 and is not refundable if you choose to have your child depart from the program early. I understand that I am responsible for tuition payment by the 10<sup>th</sup> of each month. I also understand that non-payment of tuition may result in the termination of child care services. **A two-week notice from the parent/legal guardian is required for termination of child care services.** If you withdraw your child early you will be placed on a waiting list for the next summer and will not be guaranteed a spot.
