1. Introduction

2. Communications

Billing cycles are set either on a monthly or annual basis, depending on the type of subscription plan you select when purchasing a Subscription.

At the end of each Billing Cycle, your Subscription will automatically renew under the exact same conditions unless you cancel it or Quiteoften, Inc. cancels it. You may cancel your Subscription renewal either through your online account management page or by contacting Quiteoften, Inc. customer support team.

A valid payment method, including credit card, is required to process the payment for your subscription. You shall provide Quiteoften, Inc. with accurate and complete billing information including full name, address, state, zip code, telephone number, and a valid payment method information. By submitting such payment information, you automatically authorize Quiteoften, Inc. to charge all Subscription fees incurred through your account to any such payment instruments.

Should automatic billing fail to occur for any reason, Quiteoften, Inc. will issue an electronic invoice indicating that you must proceed manually, within a certain deadline date, with the full payment corresponding to the billing period as indicated on the invoice.

5. **Free Trial**

Quiteoften, Inc. may, at its sole discretion, offer a Subscription with a free trial for a limited period of time ("**Free Trial**").

6. **Fee Changes**

Quiteoften, Inc., in its sole discretion and at any time, may modify Subscription fees for the Subscriptions. Any Subscription fee change will become effective at the end of the then-current Billing Cycle.

Quiteoften, Inc. will provide you with a reasonable prior notice of any change in Subscription fees to give you an opportunity to terminate your Subscription before such change becomes effective.

Your continued use of Service after Subscription fee change comes into effect constitutes your agreement to pay the modified Subscription fee amount.

7. **Refunds**

We issue refunds for Contracts within seven (7) days of the original purchase of the Contract.
