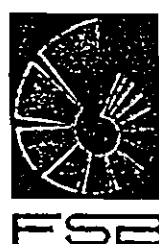

New Prescribed Fees: Amendments contained in GN R201 promulgated
in Government Gazette No 14572
dated 12 February 1993

Please note that new prescribed fees effective as from 12 February 1993 have been promulgated in the abovementioned Government Gazette.

The fees shall be as follows:

(a) For an application for the registration of a pension fund in terms of section 4 of the Act [regulation 8(d)]	200,00
(b) For the registration of a pension fund in terms of section 4 of the Act [regulation 8(d)]	50,00
(c) For an amalgamation of transfer in terms of section 14 of the Act [regulation 24(c)]	100,00**
(d) For the alteration or rescission of or addition to the rules of a fund, per alteration, rescission or addition [regulation 24(a)(iv)]	75,00***
(e) For the inspection of one or more of the documents referred to in section 35 of the Act relating to one specific fund [regulation 25]	10,00

| (k) | For the perusal of documents for the purposes of item (h) above, per A4 page or part thereof | 5,00 " |

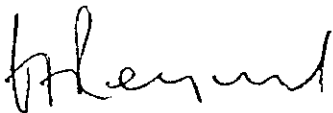
Please note that an application for registration should be accompanied by the registration fee (see (b) above) to prevent delays. Should an application be rejected, the registration fee of R50 shall be returned to the applicant.

* The fees are VAT inclusive.

** Kindly note that the responsibility rests on the transferee fund to submit the prescribed fee.

*** Due to practical difficulties, item (d) shall be applied as the fee per resolution and not per amendment.
