

Who we are

We specialize in connecting capital, insurers, and regulators to revolutionize the industry and enhance transparency and trust. Our approach merges traditional practices with blockchain standardization, enabling (re)insurance participants to conduct business based on their preferences, establishing trust through blockchain, and modernizing reinsurance.

Structure

Re is a fully licensed reinsurer, subject to regulatory oversight, ensuring comprehensive compliance. As of September 30, 2023, Re has backed \$40 million in premiums. Re consists of two entities:

- · Cover Re, Inc., ("Re") is a U.S.-domiciled Delaware holding company
- · Cover Re SPC, Ltd., ("SPC") is a Caymanregulated class b(iii) reinsurer, with U.S. IRS 953(d) election

Regulation 114 trust agreements are created for each reinsurance transaction. Collateral is adjusted based on the ceding entity's preference, either annually or quarterly. All collateral is in the form of cash and cash equivalents.

Re provides financial support through its balance sheet and open-ended fund to SPC. Re is in turn supported and funded by several multi-billion AUM funds that are prolific technology and insurance investors including but not limited to Tribe Capital, Framework, Electric Capital, Exor, and SiriusPoint.
