5. Statutory Taxes, VAT, Stamp Duty, Registration, Cons. Cost Escalation charges, Service Tax and Cess Charges payable extra as applicable.

6. The saleable area include the covered area plus proportionate common areas such as corridors, passages, lifts, lift rooms, club, staircase, underground and overhead water tanks, mumties etc.

7. As per section 194 IA of IT Act, 1 % TDS is required to be deducted w.e.f. 1st June 2013 which shall be deposited by the customer directly and Form 16B to be submitted to the company within 30 days of booking, as applicable.
