- 1. Current status of the National Center for Mental Health including the history of NCMH, medical facilities/spaces, and population and services
 - NCMH was established in 1925 through Public Works Act 3258 and formally opened on December 17, 1928. It was originally called the Insular Psychopathic Hospital and National Mental Hospital thereafter. On November 12, 1986, it was renamed National Center for Mental Health (NCMH) through Memorandum Circular No. 48 issued by the Office of the President. The National Center for Mental Health is categorized as Special Research Training Center and Hospital under the Department of Health on January 30, 1987, and is dedicated to delivering preventive, curative and rehabilitative mental health care services.
