This has reference to your Memorandum pertaining to *eFOI* request for the List of Trauma-Capable hospitals or Trauma Centers in the Philippines, annual statistics of trauma cases of the hospitals or centers from 2014-2018 and list of projected DOH Hospitals that would have trauma specialty centers

In line with this, the Health Facility Development Bureau (HFDB) coordinated with the Disease Prevention and Control Bureau and Epidemiology Bureau to gather relevant data in order to address the requested concern. We take this opportunity to inform you that the DOH thru HFDB's Philippine Health Facilities Development Plan 2017-2022 will establish Trauma Centers in the country.

Please refer to Annex attached for the draft list of DOH hospitals and the PHFDP's policy direction on the establishment of Trauma Centers. The list has been classified according to region, identified hospital, location, target year of establishment and annual statistics for trauma cases provided by the respective hospitals for your reference.

Annex A

Establishment of Trauma Centers in Selected DOH Hospitals

Accidents rank fifth in the leading causes of mortality in the Philippines. The Online National Electronic Injury Surveillance System (ONEISS) reported that from 2010 to 2016 the country had 398,988 injury cases, an average of over 50,000 cases annually, or almost 5,000 cases monthly.

The PHFDP's objectives include developing specialty centers among DOH Hospitals to increase availability and accessibility of specialty services nationwide such as major trauma facilities that will attend to injuries with the potential for prolonged disability or death, and prevent loss of life and limb. In this respect, the PHFDP fulfills relevant provisions of A.O. 2014-0002, or the "Revised National Policy on Violence and Injury Prevention," where the DOH calls for hospital care and rehabilitation to prevent further complications of traumarelated emergencies, and lessen the burden of disability due to violence and injury. The DOH the HFDB will address the gaps in the availability and accessibility of Essential Trauma Care throughout the country by establishing Trauma Centers in selected DOH hospitals with due consideration to available health human resources.

The DOH, in recognition of the Filipino people's need for Essential Trauma Care throughout the country, shall provide funding for improvement of health facilities and provision of equipment of the following DOH Hospitals for the establishment or upgrading of Trauma Centers. Please note that this listing is unofficial and still undergoing review.
