

Montgomery Crossing is a prominent retail shopping center in the Far NE Heights, located at the busy intersection of Wyoming and Montgomery Boulevards. The former Party City space has just come available, leaving behind a prime Junior Box opportunity in a submarket that boasts less than 3.5% vacancy for retail space. The box features over 130 feet of storefront and preferential pylon signage on both Wyoming and Montgomery. This new tenant would join a top performing Michaels, Walgreens, Chuck E. Cheese and Golf Mart and has recently welcomed newcomers Lucky Goose Vegan Restaurant, Kung Fu Tea, Yoshi Mame Sushi and Cuco's.

LOCATION OVERVIEW

The intersection of Wyoming and Montgomery is ranked as the 3rd highest trafficked intersection in the City of Albuquerque and has undergone major redevelopment, which continues to attract top retailers to the nearby area. Area traffic generators include Target, Natural Grocers, Starbucks, Albuquerque ER & Hospital, Slim Chickens, 7 Brew Coffee and Freddy's Steakburgers. The WyMont across the street continues to develop with 66 residential lots under construction, along with Restoration Pizza and one commercial lot remaining to add density and new retail options to the immediate area.



FLOOR PLAN: 11,475 - 13,705 SF
















