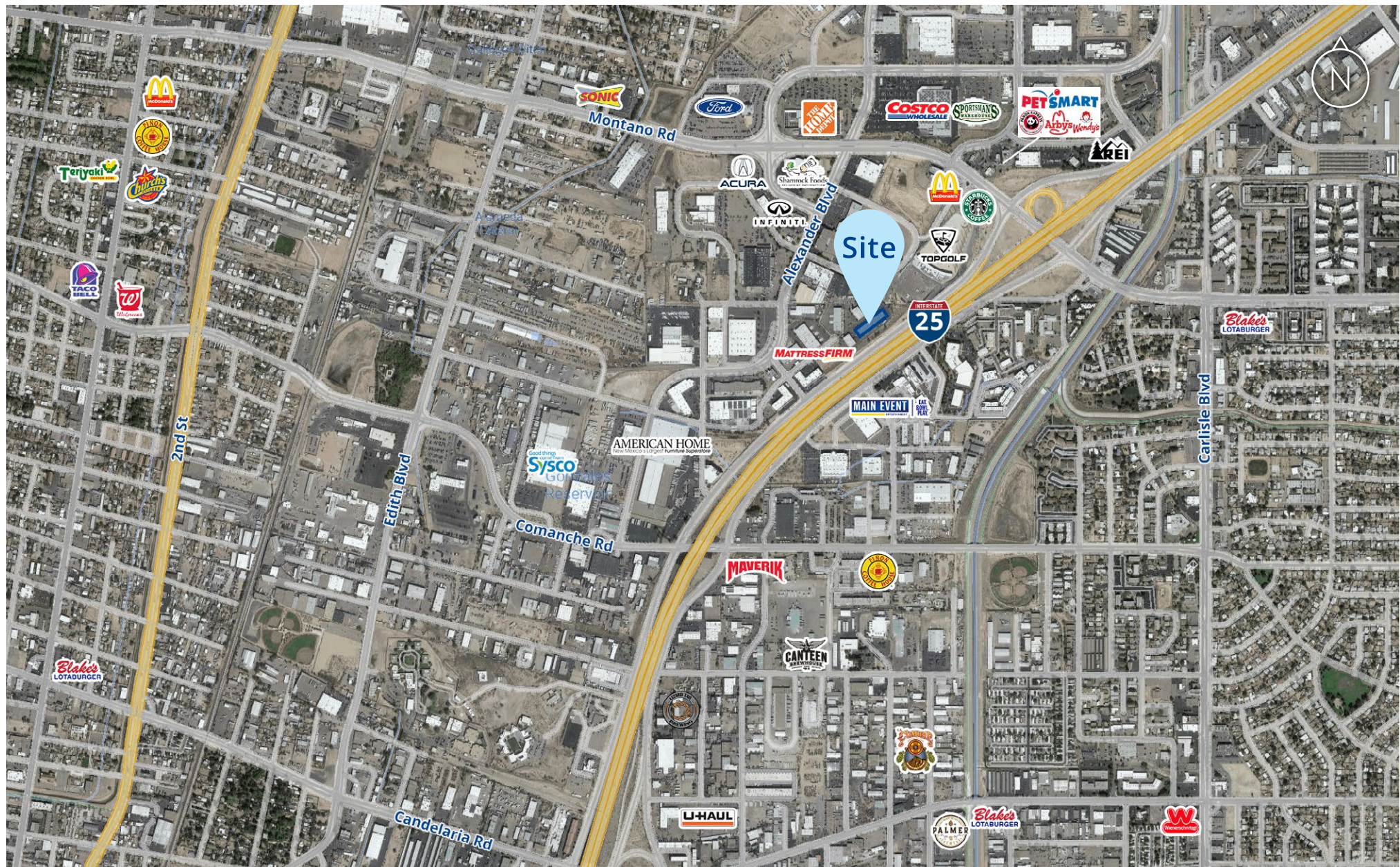

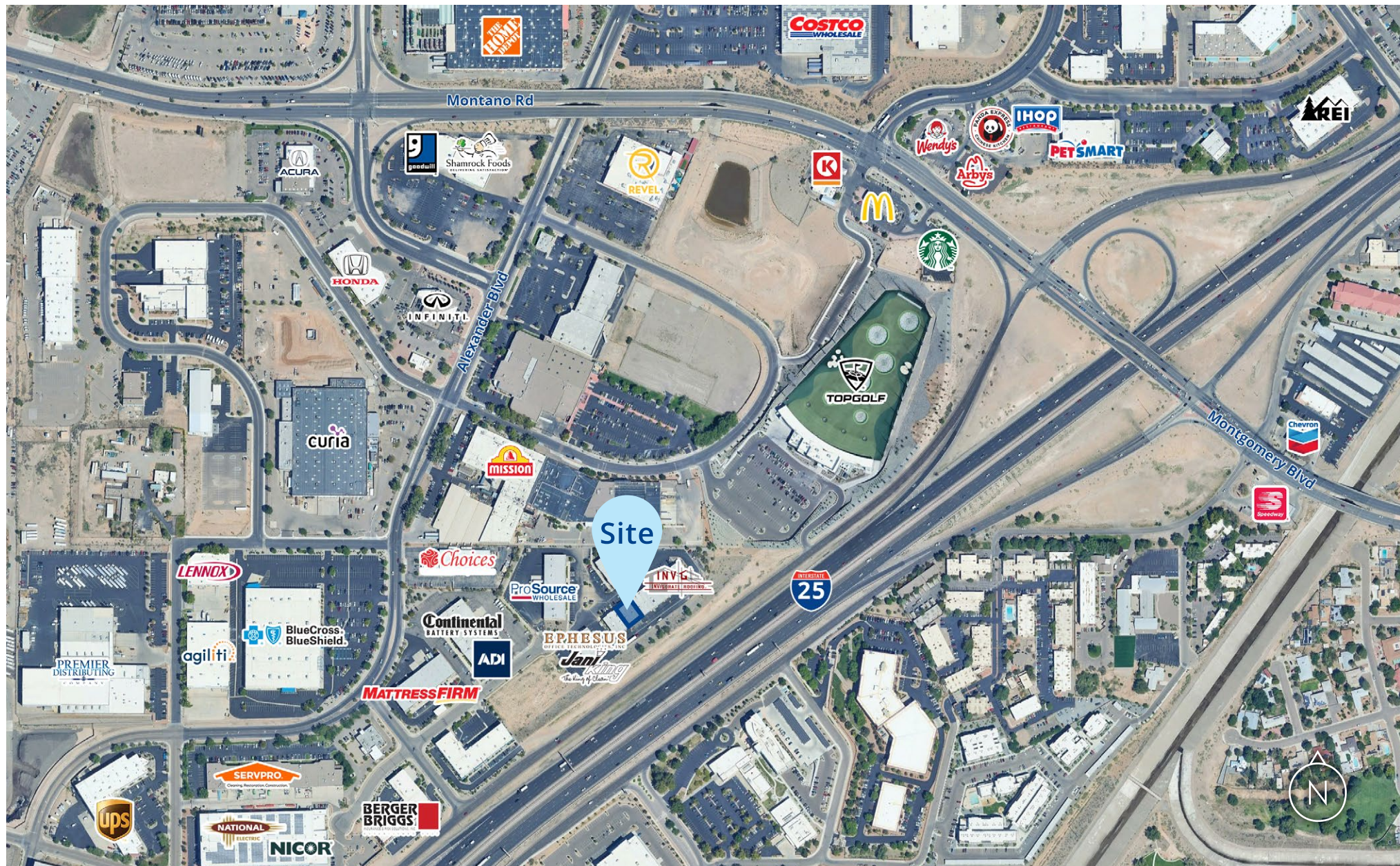

Trade Area Aerial

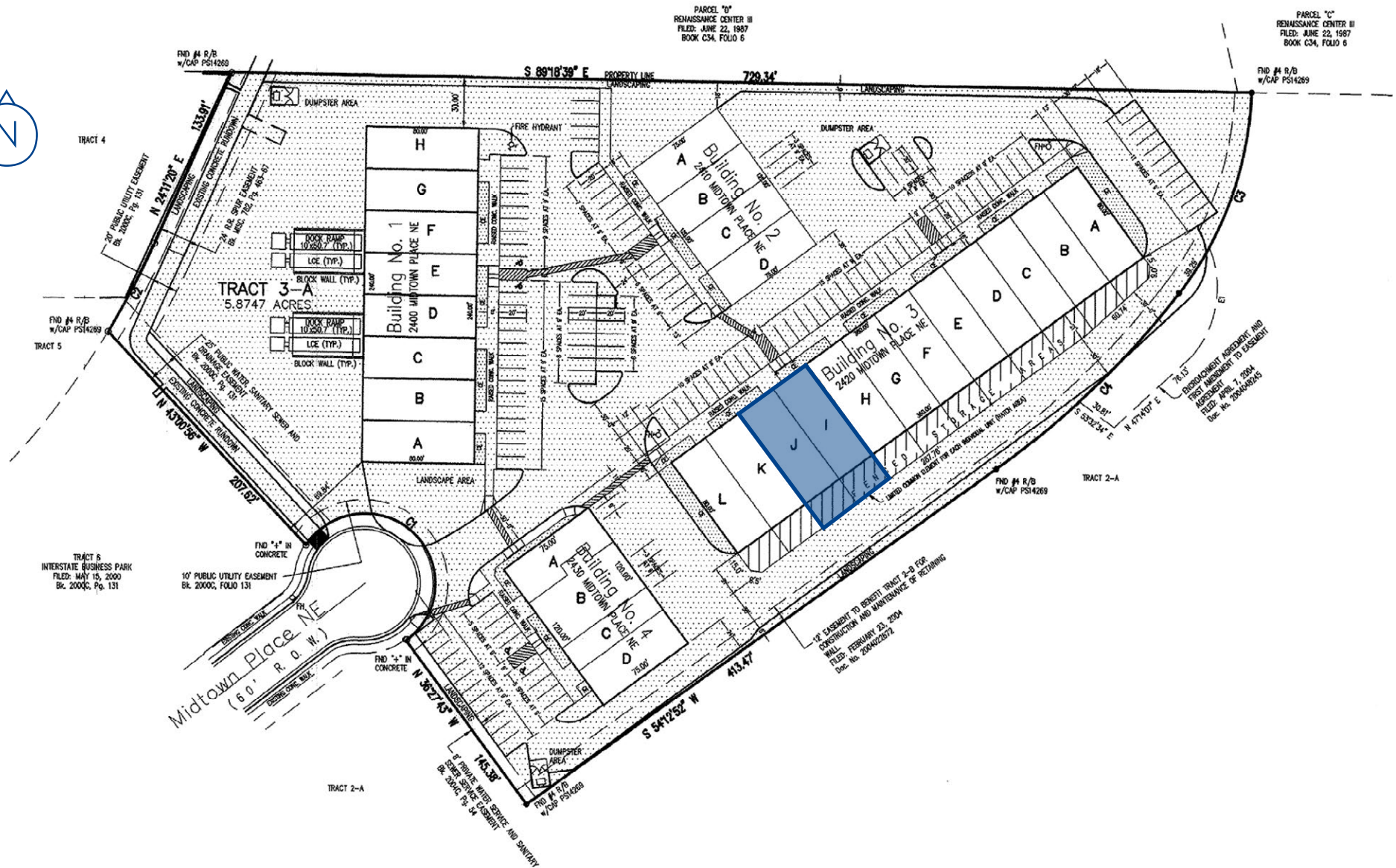

Intersection Aerial

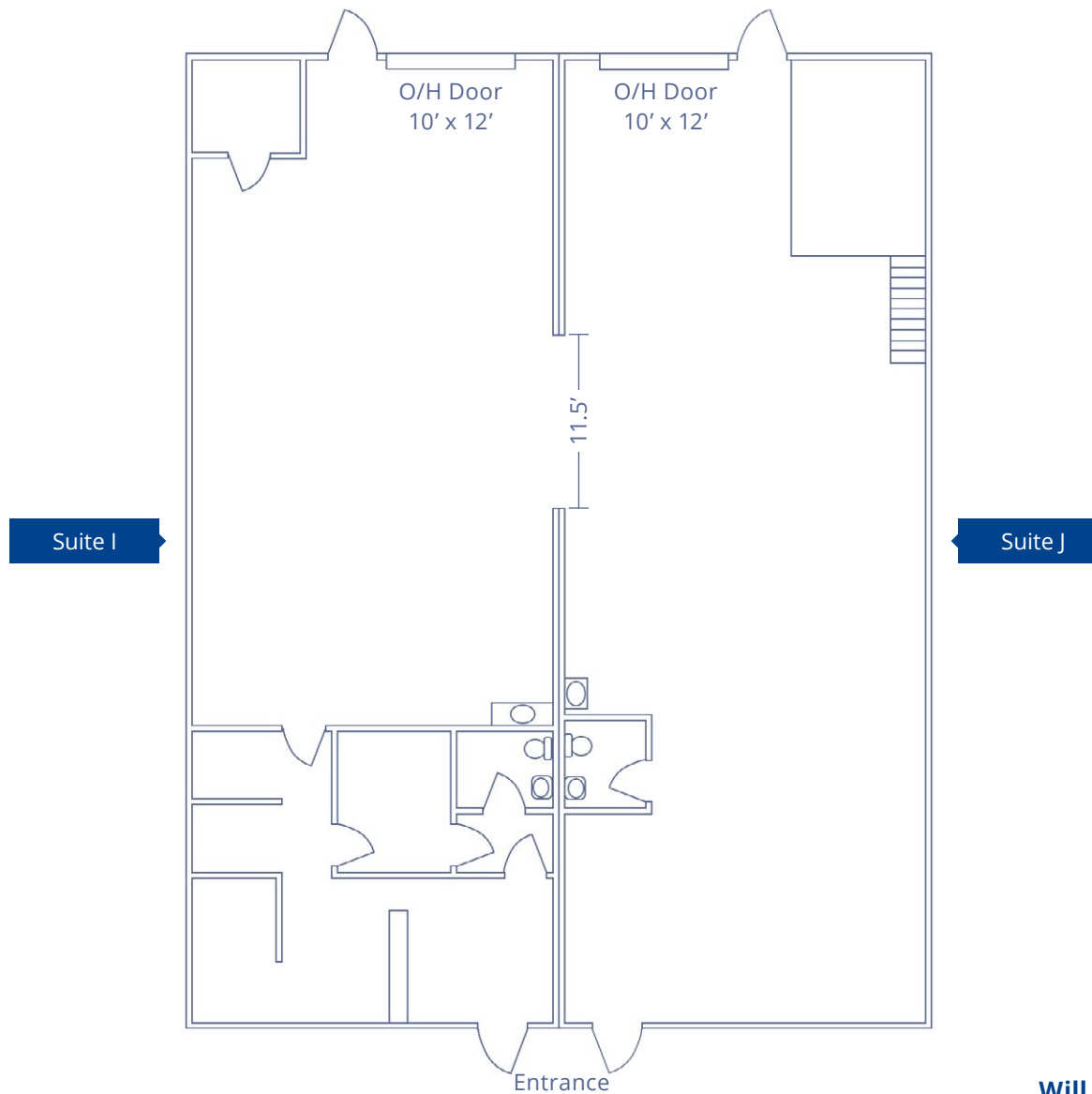


Site Plan



Floor Plan

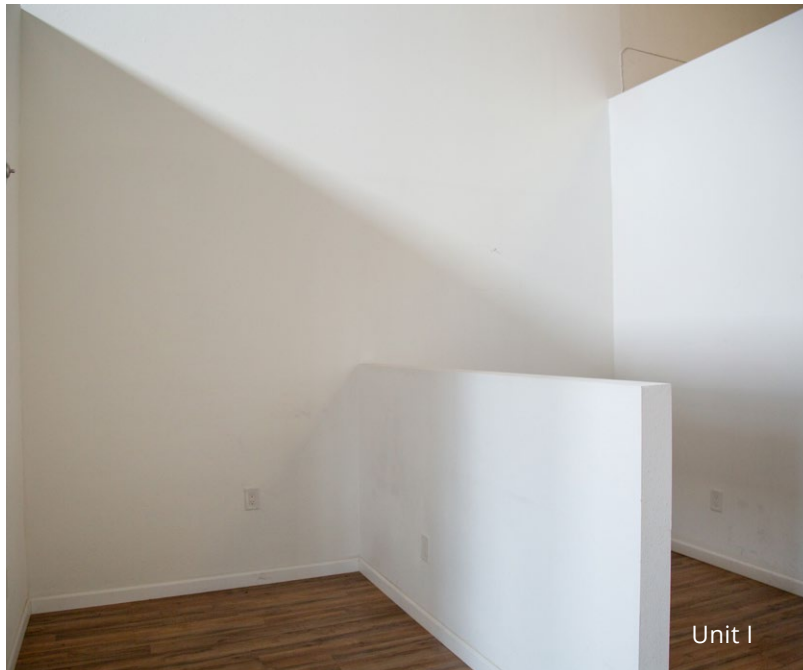

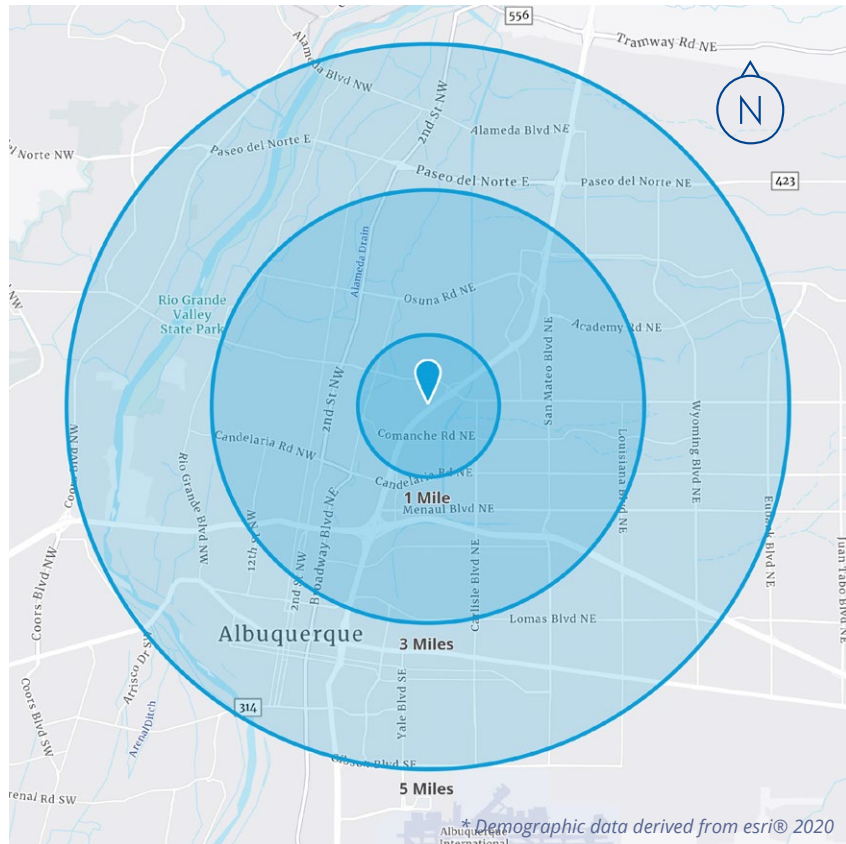
