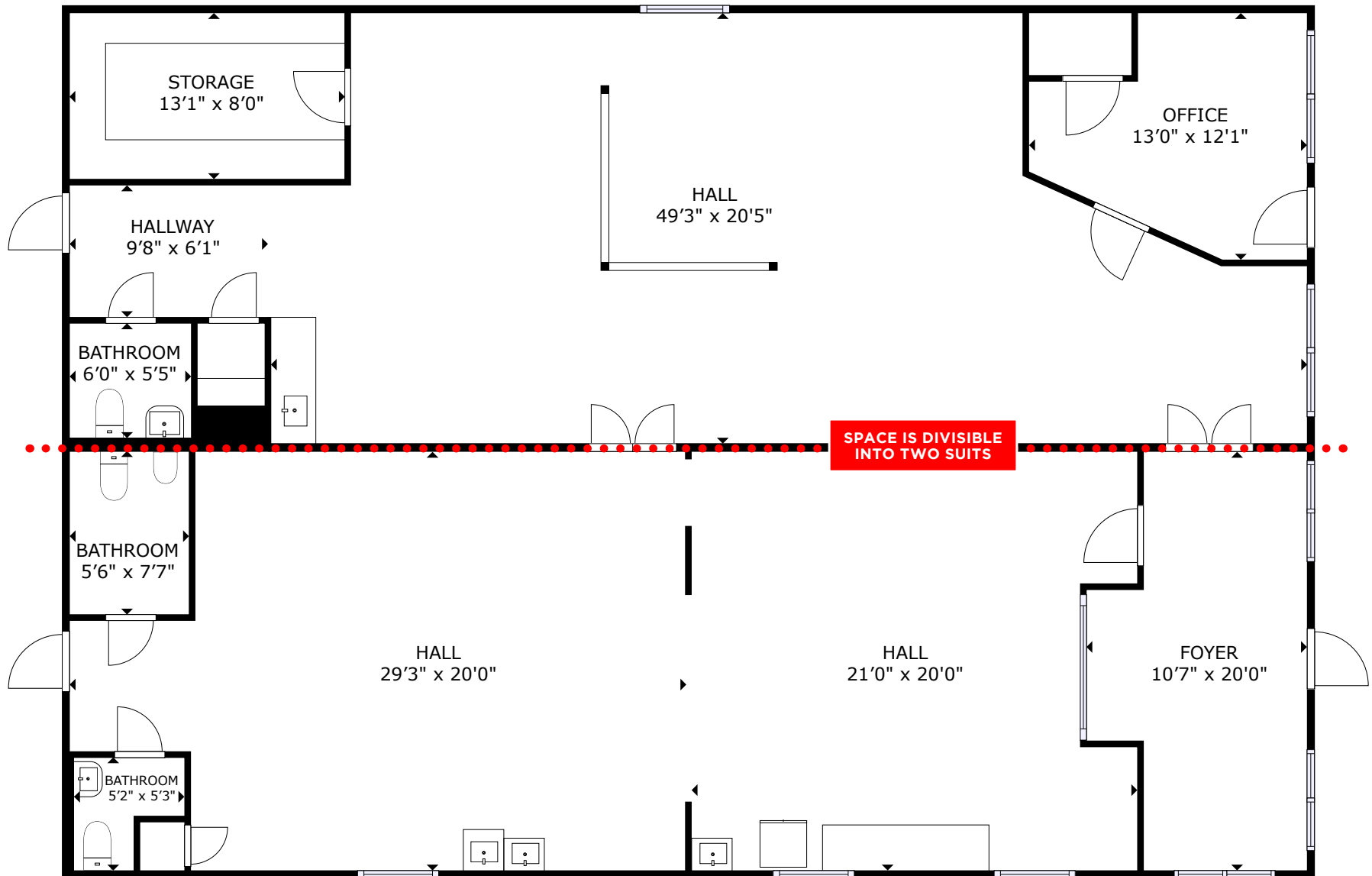


FLOOR PLAN

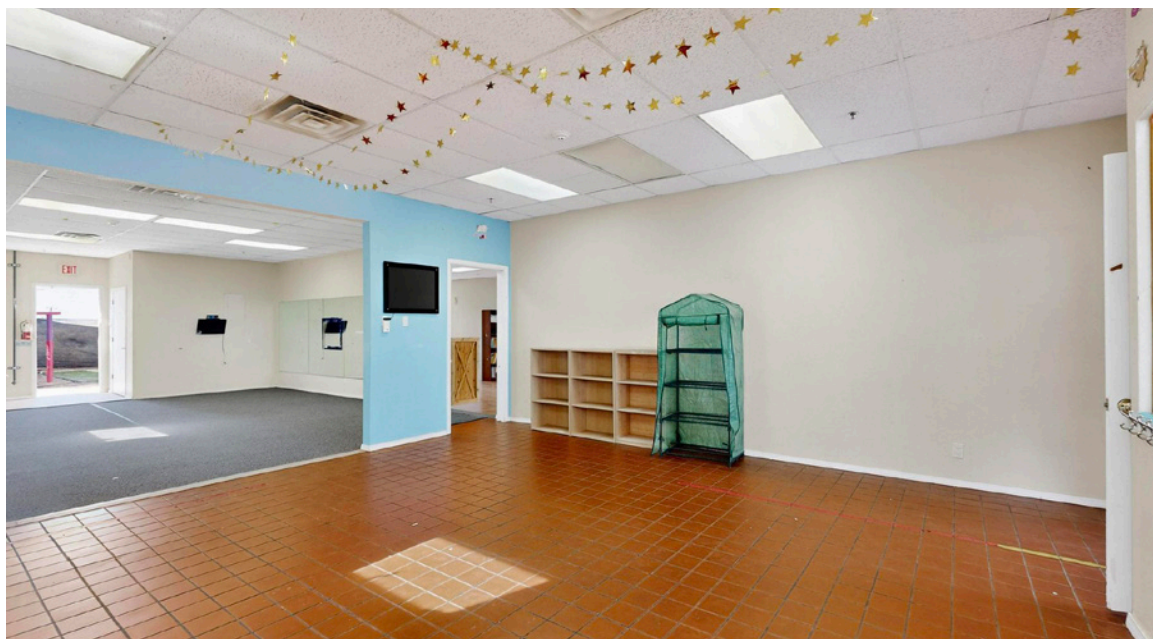

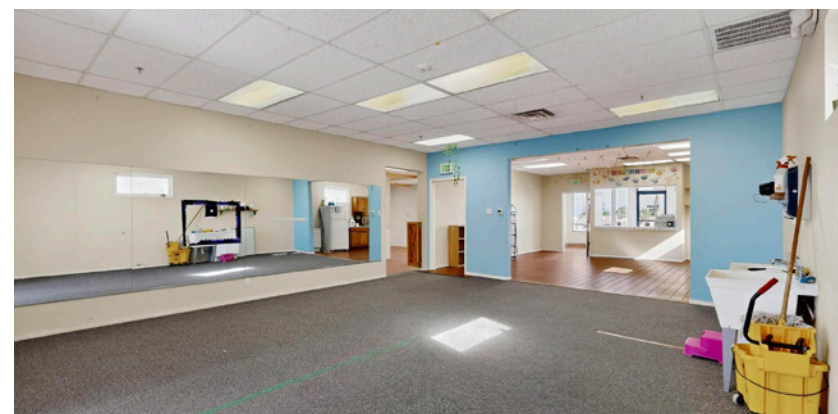

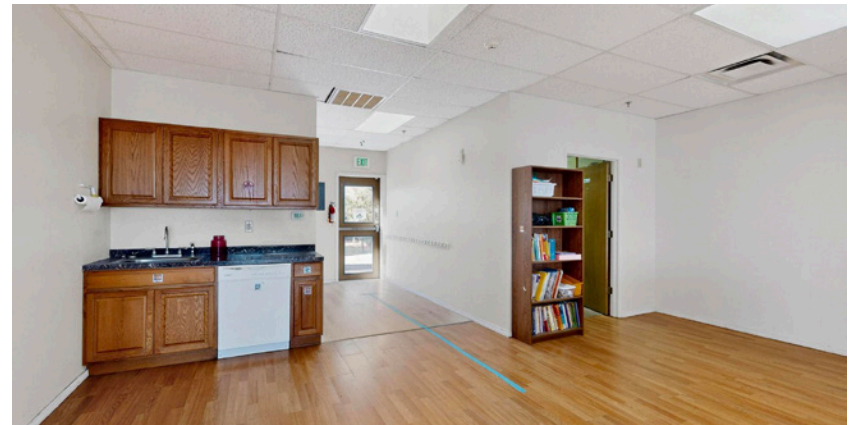

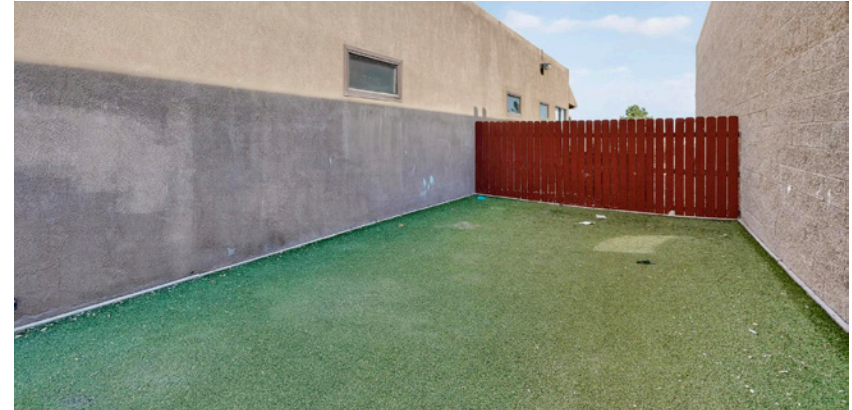


REAR BUILDING PHOTOS
