PURPOSE

C2 (Community Commercial) Zone permits a range of commercial activities that serve a community or several communities, and allow larger commercial businesses.

DEVELOPMENT REQUIREMENTS

Minimum lot size: N/A

Minimum lot width: 100 feet �

Minimum lot depth: 100 feet

Setbacks Principal Building:

1. Primary Frontage: 35 feet (min)

2. Secondary Frontage: 10 feet (min)

3. Side Setback: 10 feet (min)

4. Rear Setback: 35 feet (min)

Setbacks Accessory Buildings:

1. Primary Frontage: 35 feet (min)

2. Secondary Frontage: 10 feet (min)

3. Side Setback: 10 feet (min)

4. Rear Setback: 35feet (min)

Building Height:

1. Principal Building Height: 40 feet (max)

2. Accessory Building Height: 35 feet (max), but not higher than the height of the principal building.
