Floor Plan

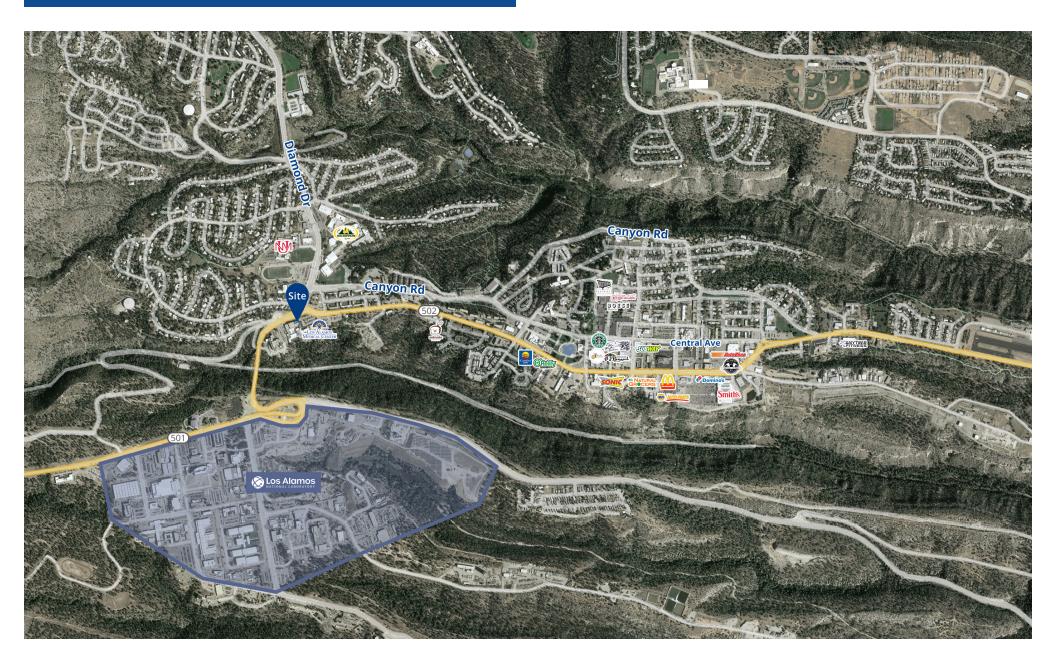




Intersection Aerial

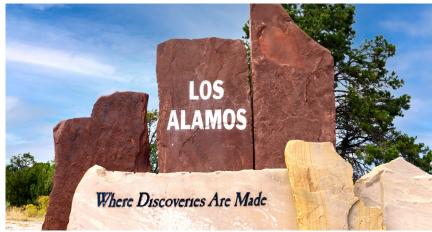

Of that workforce, approximately 7000 people commute to Los Alamos from Northern New Mexico, Santa Fe, and the Albuquerque area, nearly doubling the Los Alamos population during a standard work week.

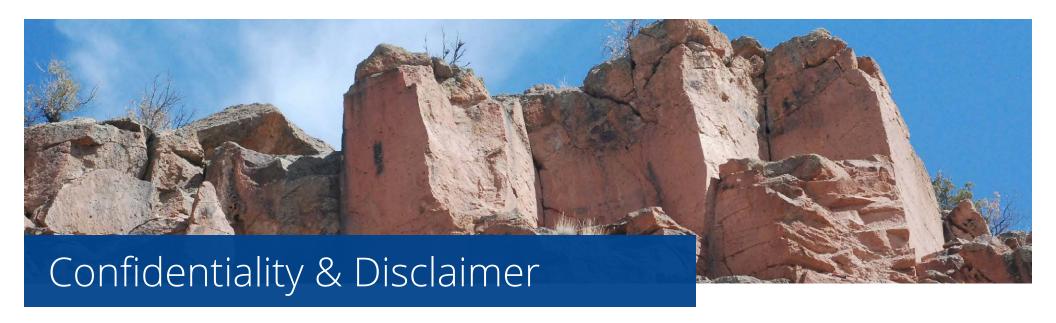
Los Alamos stands as one of the safest counties in the country, with a 2022 crime rate that is 6.8 times smaller than the national average. The unemployment rate of Los Alamos is under 1% and the average household income is one of the largest in the state at \$177,242.

Contributing to its reputation of excellence, the people of Los Alamos have among the highest levels of educational attainment of any community anywhere, with 46.6% of residents holding a graduate or professional degree and 77.5% holding a college degree. The Los Alamos public school district typically ranks as one of the top school districts in the state and in the nation and was named College Board Advanced Placement District of the Year in 2023.
