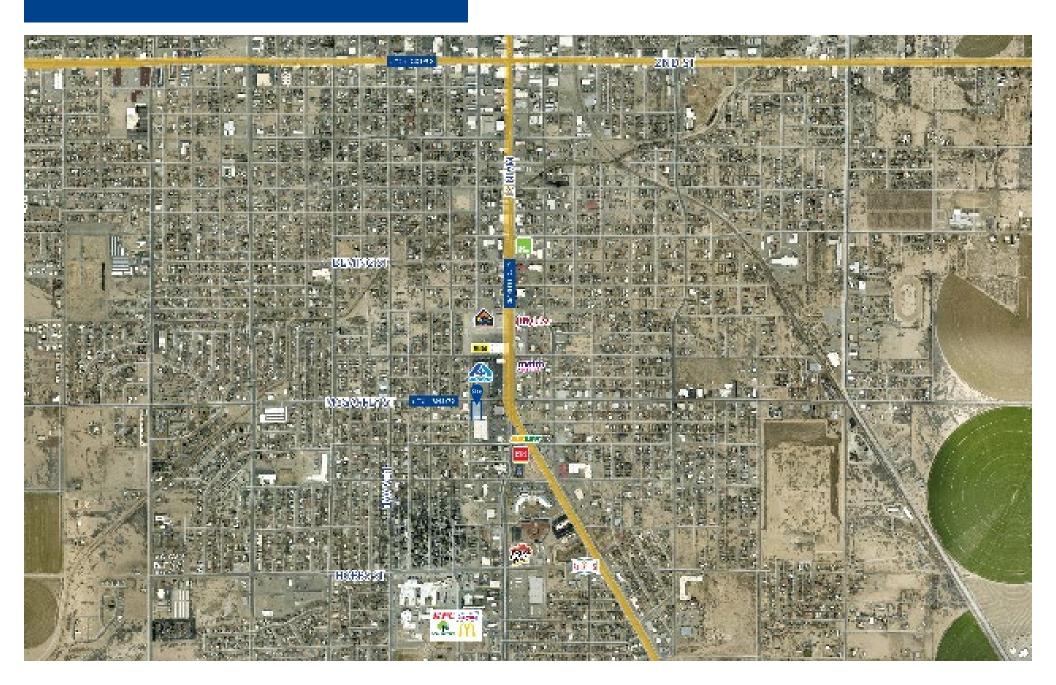

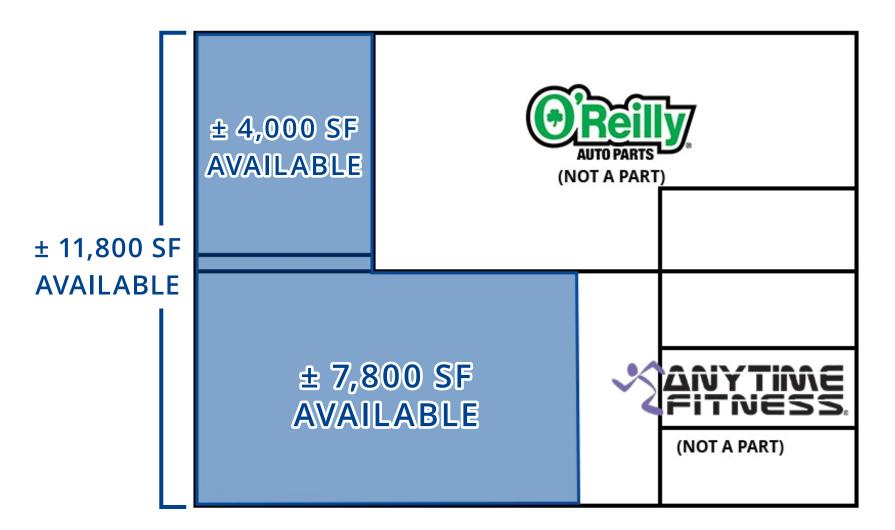
## Trade Area Aerial



### Intersection Aerial

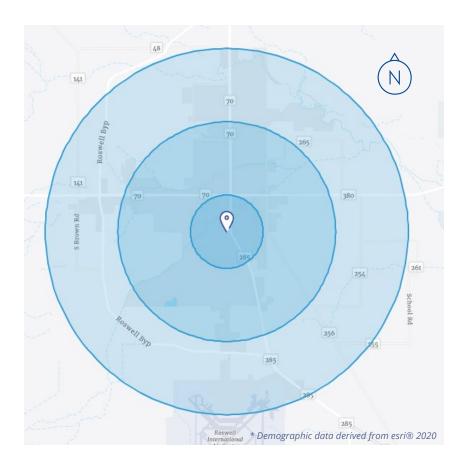


### Site Plan
