PROPERTY OVERVIEW

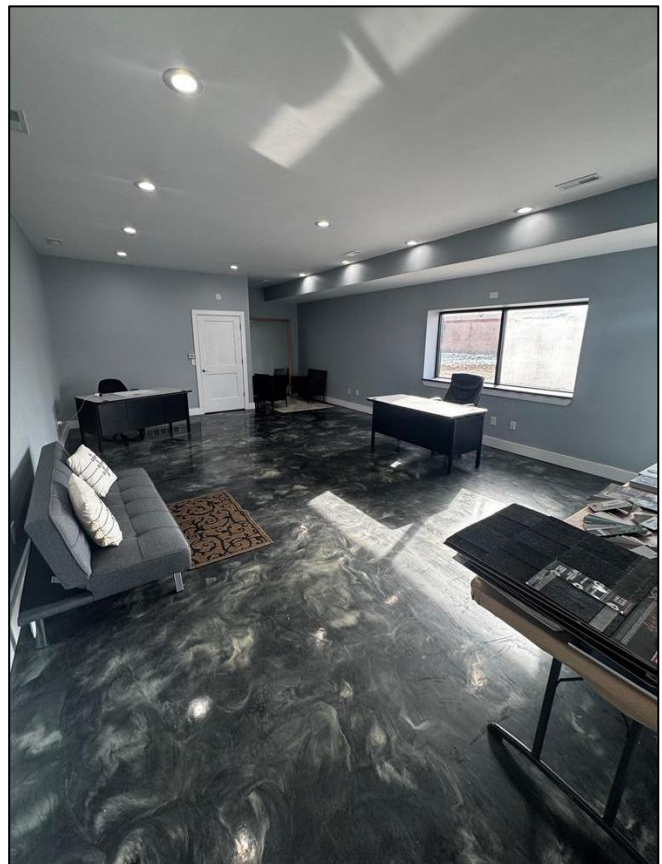
