The first two floors are Retail. The two shops are both part of Kazoo in the Mitten. The shops are heated and air conditioned by two furnaces near the parking lot. One side of L Level is ¾ finished. The south side has wonderful stone walls and a beautiful old boiler. The Third Floor is original 1880's apartments and rooms to rent.

The Parking Lot holds 23 cars off Farmers' Alley.
