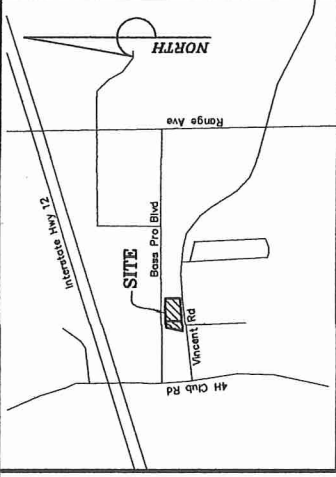
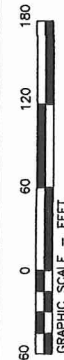




VICINITY MAP

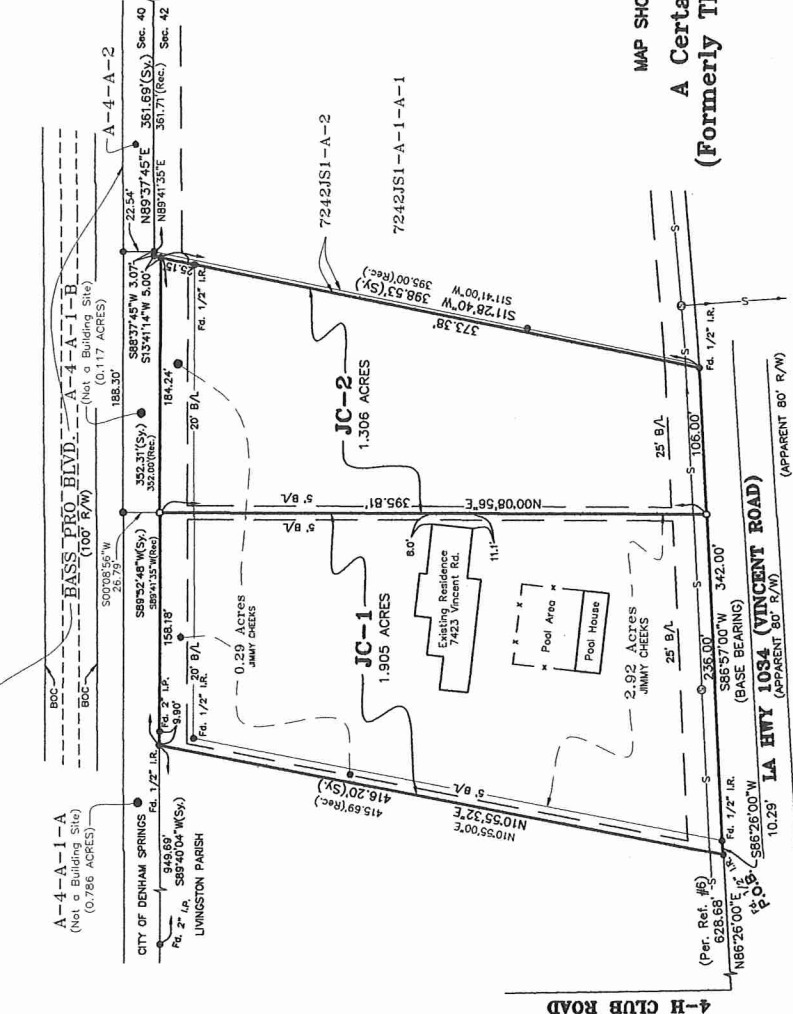
