La. Highway 1090); thence run along said southerly right-of-way line of Military Road (a.k.a. La. Highway 1090) South 55 degrees 26 minutes 58 seconds East a distance of 357.77 feet to a point; thence leaving said southerly right-of-way line of Military Road (a.k.a. La. Highway 1090) run South 34 degrees 40 minutes 15 seconds West a distance of 68.85 feet to a point; thence run South 00 degrees 12 minutes 16 seconds West a distance of 353.69 feet to a point; thence run South 41 degrees 52 minutes 14 seconds West a distance of 43.27 feet to a point and back to the Point of Commencement.
