

Sec. 7:8.2.2. Mixed Use Districts

- A. *Mixed Use Local (MX-1)*. Small-scale residential and limited nonresidential uses next to residential areas to serve nearby residents.
- B. *Mixed Use Neighborhood (MX-2)*. Small-scale multi-unit residential and limited nonresidential uses to serve surrounding neighborhoods.
- C. *Mixed Use Community (MX-3)*. Variety of mid-scale nonresidential and multi-unit residential uses to serve the community.
- D. *Mixed Use Regional (MX-4)*. Variety of large-scale nonresidential and multi-unit residential uses to serve the region.
