## Description

The property for sale is a 3,600 SF concrete block masonry 2 story office building with 3 suites on 50' x 120' lot with 12 paved parking spaces in front. The ground floor is approximately 1,800 SF with a reception area, large open work area, 4 private offices, restroom and storage. The second floor has 2 suites which could be combined:

- Suite A on 2nd floor is approximately 700 SF and has reception area/lounge, 2 private offices, storage, and restroom.
- Suite B on 2nd floor is approximately 1,100 SF and has 3 private offices, storage, shower, restroom and kitchen with refrigerator, sink and stove.

Vacant upon sale. Property taxes estimated at \$5,642 for 2025. The bitumen roof and HVAC units have been well maintained. Zoned BC-2, Business Core District. Located in Metairie, 2 blocks from Veterans Boulevard and 2 blocks from Clearview Parkway.





## Location


The property is located in Jefferson Parish, within the Metairie city limits, on Lime Street and is 2 blocks from Veterans Boulevard and one block from Clearview Parkway and the Clearview Shopping Center. There is easy access from both the east and west directions of Veterans Boulevard, and the Interstate 10 exit to Clearview Parkway offers a dedicated left turn lane onto Rye street which is the bordering street.
