
CONCEPTUAL SITE PLAN




COMMENCE AT THE NORTHEAST CORNER OF THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER OF SECTION 21, TOWNSHIP 10 SOUTH, RANGE 8 WEST, CALCASIEU PARISH, LOUISIANA, BEING AN EXISTING ONE INCH (1") IRON PIPE, THENCE SOO'40'26"E, ALONG THE EAST LINE OF SAID NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER, A DISTANCE OF 617.7 FEET TO THE PROJECTED NORTH RIGHT OF WAY LINE OF PREJEAN DRIVE AS OCCUPIED; THENCE N88'43'38"W, ALONG THE PROJECTED AND NORTH RIGHT OF WAY LINE OF PREJEAN DRIVE AS OCCUPIED A DISTANCE OF 50.0 FEET TO THE POINT OF BEGINNING; THENCE N88'43'38"W, ALONG THE SAID NORTH RIGHT OF WAY LINE OF PREJEAN DRIVE 622.53 FEET TO THE WEST LINE OF THE SAID NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER; THENCE NO0'37'36"E, ALONG THE WEST LINE OF THE SAID NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER; 86.50 FEET; THENCE S88'43'38"E, 621.93 FEET; THENCE S00'40'26"W, 86.50 FEET TO THE POINT OF
