In the identified area, the current year population is 158,637. In 2010, the Census count in the area was 153,699. The rate of change since 2010 was 0.31% annually. The five-year projection for the population in the area is 160,624 representing a change of 0.25% annually from 2020 to 2025. Currently, the population is 47.8% male and 52.2% female.

Currently, 56.3% of the 70,781 housing units in the area are owner occupied; 35.4%, renter occupied; and 8.4% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.3% are renter occupied; and 11.3% are vacant. In 2010, there were 67,648 housing units in the area - 59.4% owner occupied, 34.0% renter occupied, and 6.6% vacant. The annual rate of change in housing units since 2010 is 2.03%. Median home value in the area is \$223,133, compared to a median home value of \$235,127 for the U.S. In five years, median value is projected to change by 2.24% annually to \$249,312.
