Bed bugs	2 – 4 g/m ²	Apply powder using the DIATHOR powder puffer or a powder duster (so it is barely visible) to areas where the pests are located or hide in cracks and crevices, underneath edges of carpet, power points, wall sockets, behind skirting boards, in wall voids. When applying to power points ensure electricity is turned off at the mains power. Thorough treatment of harbourages is required to achieve suitable levels of control.
	German & <i>Periplaneta</i> spp. cockroaches.	1 - 8 g/m ²	High levels of control may take 5 or more days to achieve. Control times will likely be longer in areas of high moisture and humidity and when lower rates have been used. Use higher rates for hard to access cockroach harbourages such as wall voids. GENERAL INSTRUCTIONS:

This product will control strains of bed bugs resistant to the synthetic pyrethroids and carbamates. It is chemically stable and high temperatures will not degrade it. This product works by physical contact with the bed bugs and cockroaches causing desiccation and death. Diathor Flowable will remain effective while the deposits remain dry and uncontaminated with other materials such as dust and debris. Ready to use; no further diluents should be added. Leave powder undisturbed for as long as possible after application.

PRECAUTIONS:

Avoid contact with food, food utensils, or places where food is prepared or stored. Before use, remove or cover all exposed foodstuffs. Cover all dishes and utensils, and places where food is prepared or stored. Do not apply dust directly to humans or pets.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT. DO NOT contaminate streams, rivers or watercourses with the chemical or used containers.

STORAGE AND DISPOSAL:
