#### PRECAUTIONS

Keep out of reach of children. Avoid contact with skin and eyes and inhalation of spray mist. When mixing and applying wear protective dothing such as goggles, waterproof gloves, cotton overalls and boots. Wash hands and exposed skin before eating, drinking and after work. Wash gloves and protective dothing daily.

Cover human and pet food preparation surfaces and utensils, or, where this is not possible, wash all such items thoroughly before use.

Pets must be removed from the application area, and fish tanks must be covered.

Do not apply to furniture, carpets or upholstery where prolonged contact with humans will

occur.

Do not spray bed linens, mattresses, blankets or pillows. Do not apply to materials which come in direct contact with occupants of the bed.

The area of application must be ventilated after application. Re-entry to the application area is not permitted until the spray is dry.

#### GENERAL INSTRUCTIONS

Apply prepared spray by means of a knapsack sprayer or other suitable spraying equipment capable of delivering a coarse spray directly onto exposed surfaces frequented by pests.

#### Mixing

Shake container well before opening. For best results, make a premix of the required amount of product with an equal volume of water and stir thoroughly. Fill sprayer to half the desired volume and add premix. Agitate thoroughly and then fill sprayer to desired volume and agitate again to ensure proper mixing. Agitate prior to application if spraying is interrupted. Do not store diluted insection.

# Storage Store in closed, original container in a cool, well ventilated area away from children, animals, food and feedstuffs. Dn NOT store for prolonged periods in direct sunlight.

Spillage
In case of spillage, confine and absorb spilled product with absorbent material such as sand, clay

If an approved waste management facility is not available bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots in compliance with relevant local eovernment resulations. Do not burn empty containers or product. Do not bury waste or surplus product. Dispose of undiluted waste either by dilution and use according to the Directions for Use table or returning to the point of purchase in the original container for controlled disposal. Dispose of diluted surplus product by using according to the Directions for I Jes table
