# PyGar

General Information:-

PyGar is a fast acting natural insecticide for the control of insect pests for urban and industrial pest control.

**DANGER:** Keep out of reach of children. Avoid contact with skin and inhalation of spray mist. Do not eat drink or smoke while using. Wash hands and exposed skin thoroughly before meals and after work.

**Toxic to bees:** Do not use when bees are foraging in the area to be sprayed.

**Toxic to fish:** Avoid contamination of any water supply with chemical or empty container.

**WARNING:** Combustible liquid. May be harmful if swallowed and enters airways. Causes serious eye damage. Mild skin irritant and may cause an allergic skin reaction. Facial contact may result in temporary facial numbness. May cause allergy or asthma symptoms or breathing difficulties if inhaled. May cause harm to breast fed children. May cause damage to organs through prolonged or repeated exposure. Harmful to terrestrial vertebrates.

**PRECAUTIONS:** Keep away from heat, flames, hot surfaces. Wear protective gloves and eye protection. Avoid contact with skin and inhalation of spray mist. In case of inadequate ventilation, wear self contained breathing apparatus. **DO NOT** apply onto or into water.

## FIRST AID

**Swallowed:** Do not induce vomiting. Immediately call the National Poisons Centre 0800 POISON (0800 764 766) or a doctor for treatment advice.

**Eye:** Immediately hold the eyes open and wash continuously for at least 15 minutes with fresh running water. Ensure irrigation under eyelids by occasionally lifting the upper and lower lids. Transport to hospital or doctor without delay. Skilled personnel should only undertake removal of contact lenses after an eye injury.

**Skin:** Immediately flush body and clothes with large amounts of water, using safety shower if available. Quickly remove all contaminated clothing, including footwear. Wash affected areas thoroughly with water (and soap if available) for at least 15 minutes. Get medical advice. **Inhaled:** Remove to fresh air. Lay patient down. Keep warm and rested. If breathing is shallow or has stopped, ensure clear airway and apply resuscitation. Transport to hospital or doctor without delay.

**ADVICE TO DOCTOR:** Treat symptomatically.

## MIXING

Add PyGar to water at the recommended rate and mix well before spraying. Maintain agitation and agitate frequently whilst spraying.

## DIRECTIONS FOR USE

For the control of flying and crawling insects in dairy food preparation areas, meat packing, pack houses, animal slaughtering premises, factories and residential housing. This insecticide may be used in all areas. This insecticide may only be used in edible areas as a space spray provided that, before use, all edible products and packaging materials, except canned products, are removed from the room. After using this insecticide the room must be adequately ventilated, and all food surfaces thoroughly washed with potable water before edible products and packaging material are returned to the room.

	Thermal fogging with fogging agent.	300ml of PyGar plus 200ml of fogging agent plus 500ml of water	35ml of diluted solution per 100m <sup>2</sup>

## SPILLAGE, DISPOSAL & FIRE FIGHTING

Contain and collect spillage for disposal in landfill. Triple rinse empty containers using washings to make up spray. Dispose of clean empty containers to Agrecovery recycling or to suitable landfill. In case of fire extinguish with alcohol-resistant foam, carbon dioxide, dry powder or water fog. Use fire-extinguishing media appropriate for surrounding materials. **DO NOT** use water jet as an extinguisher, as this will spread the fire.

Store in a well ventilated cool dry place away from direct sunlight and heat. Contact your supplier for further information.
