DIRECTIONS FOR USE:

SITUATION

Commercial, Industrial, Rural and Residential Buildings.

PEST

Pest bird species including feral pigeons, starlings, barn swallows and common myna. Do not place within 2 metres of nests containing eggs or young birds of protected bird species.

PREPARATION

Product is to be installed by operators trained under Ensystem's BIRD AWAY program that can be accessed through <http://www.ensystem.com.au/BirdAway.html>. When working at height, product should be installed by appropriately trained persons using required safety equipment. Ensure appropriate personal protective equipment is used when preparing the site. Remove all vacant nests and other related debris. For effective application of AVITHOR BIRD AWAY all surfaces within the installation area must be thoroughly cleaned and free from faecal and organic matter.

Enhanced efficacy will be gained by treating the cleaned areas with a fine mist spray of an alkaline disinfectant (e.g. AVITHOR GUANAWAY™). Do not over-wet as this will lengthen drying time and inhibit adhesion of silicone sealants. AVITHOR BIRD AWAY will only be completely effective if the site is properly cleaned before installation.

APPLICATION

Cut off cartridge seal, cut nozzle to provide for a 10 mm hole and apply 15 – 17 g of AVITHOR BIRD AWAY into an AVITHOR BIRD AWAY Dish (as supplied by Ensystem).

Secure AVITHOR BIRD AWAY Dishes to surfaces using either a quality silicone sealant or AVITHOR BIRD AWAY magnets or clips and space as follows:

- High pressure roosting and nesting areas** 15 – 20 cm spacings
- Medium pressure areas** 20 – 30 cm spacings
- Low pressure areas** 30 – 50 cm spacings

Repeat cleaning process and replace AVITHOR BIRD AWAY Dishes if birds return to treated site.
